General Election Date Change

Governor Parson Announced April 7 Municipal Elections are Postponed Until June 2 in Response to COVID-19. The Executive Order declares that ballots already printed for the April 7 election may be used at the postponed date of June 2. Voters who have attained the age of 18 by April 7 will be allowed to cast a ballot. The Executive Order also states: The closing date to register to vote in this election remains March 11; The deadline for filing as a write-in candidate for office remains March 27 at 5 p.m; The deadline to apply for an absentee ballot shall be May 20; Inperson absentee ballots may be cast until 5 p.m. on June 1; The deadline by which absentee ballots must be received by the election authority shall be 7 p.m. on June 2; Military and overseas voters must request a ballot from an election authority by 5 p.m. on May 29, and the deadline for local election authorities to make ballots available to such voters is April 18. Military and overseas ballots must be received by the election authority by June 5. The Village encourages residents to contact the Warren County Clerk's office to arrange for absentee voting in order to keep our election polling judges and our residents safe. Income Tax Deadline Change

On March 18, 2020, the Treasury Department and the Internal Revenue Service announced that they are providing special payment relief to individuals and businesses in response to the COVID-19 Outbreak. The filing deadline for tax returns remains April 15, 2020. The IRS urges taxpayers who are owed a refund to file as quickly as possible. For those who can't file by the April 15, 2020 deadline, the IRS reminds individual taxpayers that everyone is eligible to request a six-month extension to file their return. Income tax **payment** deadlines for individual returns, with a due date of April 15, 2020, are being automatically extended until July 15, 2020, for up to \$1 million of their 2019 tax due. This payment relief applies to all individual returns, including self-employed individuals, and all entities other than C-Corporations, such as trusts or estates. IRS will automatically provide this relief to taxpayers. Taxpayers do not need to file any additional forms or call the IRS to qualify for this relief. 
How To Protect Your Family

<u>Know how it spreads</u>: There is currently no vaccine to prevent Coronavirus disease 2019 (COVID-19); The best way to prevent illness is to avoid being exposed to this virus; The virus is thought to spread mainly from person-to-person - between people who are in close contact with one another (within about 6 feet) and through respiratory droplets produced when an infected person coughs or sneezes; These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

<u>Take Steps To Protect Yourself:</u> Clean your hands often; avoid close contact with individuals.

<u>Take Steps To Protect Others:</u> Stay home if you're sick; Cover coughs and sneezes; Wear a facemask if you are sick; Clean and disinfect.


