TABLED/ CONSIDER DISCUSSIONS ON ZONING CHANGES RE: APARTMENTS BUSINESS:ON MAIN STREET

The Board discussed some of the critical issues involved in allowing the apartments on Main Street, which include a plan for parking and refuse removal.

Mayor Stoddard said Main Street has a two hour parking limit and we do not allow overnight parking in the municipal lots.

Sanitation placement as well as removal will also be a big factor in the number of apartments that can be considered on Main Street.

The Board said the discussion would continue with the Village Attorney at the Regular Meeting of May 4th.
