#### **COMPLIANCE**

The Virginia POA Act, Sec 55-513, permits the Board of Directors, or their designated committee to:

Impose fines not to exceed \$50.00, or \$10.00 per day for offenses of a continuing nature, not to exceed 90 days.

Members are entitled to a proper hearing prior to fines and suspensions being implemented.

#### BRPOA Board of Directors Meeting August 12, 2017

**IN Attendance:** Paul Glass, Hal Davis, Rick Gray, William Earhart, Joe Brown, Clarence Craig, Donna Frago, Dan Kilcoyne, and GM Denny W. Kelly

Absent: Jane Sleight

**Approval of the Agenda:** Craig moved for approval of the amended agenda, Gray seconded and approval was unanimous.

**Approval of the Minutes:** Minutes for the July Board meeting were presented and Davis had some late corrections. *Gray moved for approval of the amended minutes, Frago seconded and approval was unanimous.* 

**Signage:** Earhart moved that the Board authorize the GM to approve signage list for security services and warning of K-9 dogs on member's property at his discretion. Frago seconded and approval was unanimous.

**Trademarks:** Davis moved that the Board authorize the GM to register the following names as official trademarks. The names are: Blue Ridge Property Owners Association, BRPOA, Shoreline, Blue Ridge Shores BRS, and Lake Louisa. Earhart seconded and approval was unanimous.

**Window Replacement:** Further window replacement is required in the office meeting room. The GM has a written proposal for \$1360 for the work. The funds for the work are covered in the five-year plan, within line item RP-42. *Craig moved to approve the work, Earhart seconded and approval was unanimous.* 

**Pier Replacement:** Three community piers are unsafe. Craig moved that the Board replace two piers at areas #3 and #4. The new piers should be a standard size of 35ft X 5ft, with the current railings also replaced. The pier at area #10 should be removed. The Board should accept the lowest bid with the total cost not to exceed \$9810. Frago seconded and approval was unanimous.

#### **Revision to the By-Laws:**

BRS Members are responsible for any guests they allow into BRS. All guests using community facilities must be accompanied by the BRS member or have the member email the BRS Office the guests' information including their names and vehicle identification.

#### The first reading states:

Any member or Non Member Occupant extending guest privileges will either accompany their guests to the common area being used or send an email to the office with the guest's name, number of people with them, and type of vehicle being driven. Visitors not accompanied or identified by email will be asked to leave by the GM or his/her designee.

Motion made by Frago, seconded by Davis to approve on first reading. Motion passed unanimously.

**Approval of the Minutes:** Minutes for the August Board meeting were presented. *Gray moved for approval, Brown seconded and approval was unanimous.* 

Revision to the By-Laws: BRS Members are responsible for any guests they allow into BRS. All guests using community facilities must be accompanied by the BRS member of have the member email the BRS Office the guests' information including their names and vehicle identification. The second reading (again) states: Any member or Non Member Occupant extending guest privileges will either accompany their guests to the common area being used or send an email to the office with the guest's name, number of people with them, and type of vehicle being driven. Visitors not accompanied or identified by email will be asked to leave by the GM or his/her designee.

Gray moved to approve the by-laws addition, Earhart seconded and approval was unanimous.

**Signage:** Brown delivered proposed new signage to attempt to limit truck traffic over the dam. Those designs were discussed.

Davis moved to authorize the GM to spend no more than \$500 on the new signage and to position them as he deems appropriate. Sleight seconded and approval was unanimous.

**Hickory Creek Bridge Closure:** Davis moved to authorize the closure of the Hickory Creek Bridge for approximately two weeks, from Oct 9 to Oct 20 for timber replacement. Earhart seconded and approval was unanimous.

**Dam Recertification:** Earhart moved to authorize the GM contract with James Luther, PC for the amount of \$10,000 and with Stantec Consulting for the amount of \$16,950 to move this process forward. Brown seconded and approval was unanimous

**2018 Fireworks Display:** The firm Pyrotecnico bid \$5800 to present next year's fireworks on Saturday, Jun 30, 2018. *Gray moved to approve the contract with Pyrotecnico for \$5800, with no funds due until Feb-2018. Craig seconded and approval was unanimous.*

# **Plant Guide**

#### VIRGINIA CREEPER

# Parthenocissus quinquefolia (L.) Planch.

Plant Symbol = PAQU2

Warning: Virginia creeper berries are highly toxic to humans and may be fatal if eaten. Its sap can also cause skin irritation in some people.

#### Alternate Names

Woodbind, woodbine, false grapes, five leaves, American Ivy, five leaved Ivy, thicket creeper

#### Uses

Wildlife: The berries of this plant are eaten by many animals especially birds. Animals such as mice, skunks, chipmunks, squirrels, cattle and deer will munch on the leaves and stems. This plant provides great cover for small animals because of is thick foliage. The vines provide birds with perches, nesting places and leaf surfaces to find food.

Erosion Control: Virginia creeper is used as a ground cover to control soil erosion in shaded areas and on slopes.

Medicinal: The bark has been has been used in domestic medicine as a tonic, expectorant, and remedy. The berries have been found serviceable in rheumatic complaints and are found to help cure dropsy. The roots are used for diarrhea and the bark and twigs are made into cough syrup.

Ornamental: It is often cultivated as an ornamental because of its fall foliage and to replace many exotic plants. It is an excellent covering for walls, trellises, arbors or fences. It may also be grown on the ground to cover old stumps, rock piles and other "eyesores".

#### Description

Vine Family (Vitaceae). Virginia creeper is a native, fast-growing, perennial, woody vine that may climb or trail along the ground. The leaves are compound, containing five leaflets. Leaflets range in size from 2-6 inches and have toothed margins. The leaflets are red when they first emerge but turn green as they mature. In the fall, leaves turn a bright red to maroon color. The inconspicuous green color flowers are borne in small clusters during the spring and followed by small clusters of fruit in early summer. This fruit is a 4 to 6 mm diameter bluish-black berry that usually contains two to three seeds. The vines adhere to surfaces by means of five to eight branched tendrils ending in cup-like adhesive tips. New stems are brownish-green and finely hairy but gradually acquire pale, raised dots and turn purplish-brown with age.

Virginia creeper is often confused with eastern poison ivy (*Toxicodendron radicans*), however; a clear distinction between the species is that eastern poison ivy has three leaflets and Virginia creeper has five leaflets. The PLANTS Web site at plants.usda.gov contains an image of eastern poison ivy.

Reproduction: Virginia creeper flowers from June to August, matures fruits from August to October and drops fruits from September to February. The seeds are dispersed by birds. The seeds usually germinate the first or second spring after dispersal.

#### Adaptation and Distribution

Virginia creeper is found throughout the southern, midwestern and eastern half of the United States. The plant is also native to northern Mexico and southeastern Canada from Nova Scotia to Ontario. Virginia creeper can be found in new and old forests and forest margins. It can also be found on the borders of clearings, on trees, along fencerows and streambanks. The plant thrives in partial shade to full sun. It prefers acidic soil, and tolerates a wide range

of soils from dry sandy soils to moist loamy soils. The plant is also salt tolerant. The species is cultivated as an ornamental in many moist temperate areas of the world.

For current distribution, please consult the Plant Profile page for this species on the PLANTS Web site.

#### Establishment

Seeds can be sown in the fall or in the spring after cold-moist stratification. Seeds should be drilled 3/8 inches deep in soil or mulch. Optimum planting is 10 plants per square foot. Virginia creeper can also be propagated from hardwood cuttings or layering.

#### Management

Once Virginia creeper is well established, it grows quickly. It must often be pruned to prevent it from getting out of control. The species can handle periods of sparse rain fairly well; however, if a drought persists, water the vine every week soaking the soil at least six inches. Virginia creeper can be a rampant grower with a climbing height of over 60 feet and a spread of over 50 feet.

#### Pests and Potential Problems

No pests or diseases are of major concern, but mildews, leaf spots, canker and wilt are occasional problems. Virginia creeper is sometimes bothered by beetles, scale, leaf hoppers, caterpillars and other leaf eating insects. These pests cause the leaves to be ragged and tattered.

Some literature suggests that Virginia Creeper is not poisonous, but the sap of the plant contains oxalate crystals and can cause skin irritation and rashes in some people.

Ornamental: If you grow Virginia creeper on walls, make sure you want it as a permanent fixture. Once it is established, it is very difficult to remove. You could damage the wall trying to remove the species.

#### **Environmental Concerns**

Virginia creeper will grow up any tree and most shrubs. This species will slowly kill the host on which it is growing, because it prevents the host from receiving an adequate amount of sunlight. It can also crowd or choke other plants.

#### Control

Please contact your local agricultural extension specialist, or county weed specialist to learn what works best in your area. If chemicals are recommended be sure to read the label and follow all application and safety instructions for each control method. # Cultivars, Improved, and Selected Materials (and area of origin)

The commercial nursery trade has developed three Virginia creeper cultivars:

'Engelmanii'-This has smaller leaves and better clinging characteristics than the species general population.

'Monham'-The leaves have white variegations.

'Variegata'-It is less vigorous than the species'
general population, but the leaves are marked with
yellow and white then develop a pink and red color in
the fall.



# **Virginia Boating Safety Class**

Section II, Policies, Rules, and Registration; D. Boats requires that all Motorboat Operators complete this class or an equivalent and present proof of Compliance to receive their boating registration this

year, (2017). This policy has been phased in since 2011 and effective July 1, 2016 all operators of motor boats regardless of age, shall meet the requirements. If you have completed this class in another State and have that certificate of completion, it will meet the BRS requirements. An operator under direct supervision of an individual who has met this requirement is not required to take this class.



The Office cannot issue registration/decals unless the above requirements are met and a copy of completion is submitted for your file.

#### **Compliance Committee Report**

**Septic System Inspection** 

All members are required to have standard septic systems inspected every five years by a certified septic company. Alternative pumping systems must be inspected and or pumped every year. Please submit your certification to the office. This is not only a BRS requirement but a requirement from the Commonwealth of Virginia enforced by all county health departments. The BRS office notifies each member at the beginning of the year when your system is due for inspection. You have until December 31 to comply. Members that do not comply may be fined \$10 per day for 90 days. Our Committee recently took this action on three members and this information may be posted in the Shore Line by name and Street Address. There are no exceptions. This rule is to ensure the health of our lake and the health of our water supply. Thank you for keeping Blue Ridge Shores a healthy community for all.

# **POSTED SPEED LIMITS**

The Association Office receives complaints routinely for people driving throughout the Community and exceeding the posted speed limits. The Louisa County Sheriff's Department has been most helpful in their attempts to resolve this problem. They have jurisdiction to write summons for speeding or reckless driving on Association Roads and the results go into Louisa County General District Court and if found guilty those results will be posted with DMV and appear on your Virginia Driver's License Records.

The Sheriff's Department has assured us of enhanced efforts to resolve these problems and will be placing Deputies in the areas of complaint. Please be considerate of yourself and others as it relates to the potential consequences of traveling too fast within the Community.

Past-due/Disconnect notices will be mailed on 11/1/17 for any account that is not paid by the 10/31/17. *Water meters will be disconnected for the 3rd qtr. on 11/15/17*. Please note the 11/15/17 date is the actual disconnect date. Payment must be received prior to 11/15/17 to avoid disconnection of your water service. YOU WILL NOT RECEIVE ANY ADDITONAL NOTICES OR REMINDERS OF THE DISCONNECT DATE.

#### 3rd Quarter Water Usage

When reviewing your current water bill be mindful that we typically see our highest usage during the 3rd quarter of the year. Part of this can be attributed to watering of lawns, filling of swimming pools, sprinkler usage, power-washing, increase of house guests, etc. These are all activities that can greatly impact your total water usage for the quarter.

#### O & A ... Why does my water appear to be white, cloudy, or milky?

A. During this time of the year when water coming into the house is colder than the temperature inside the house, your tap water may look cloudy. Cold water holds more air than warm water does. When cold water from the water mains outside comes inside our heated homes and the water begins to warm, the air must escape. It does so bubbling out in tiny air bubbles, making the water look milky.

The water is safe to drink and there is no "fix" during this time of the year since outside temperature isn't controllable. However, you can fill a pitcher or container with water and let it stand for a short time. The water should return to normal as the air escapes.

#### Winter Is Just Around the Corner....

With summer winding down now is the time to plan for the winter months ahead, especially if your residence will be vacant during those months. The Sheriff's Department is working in conjunction with the Association to resolve this problem. Additionally, for those that continue to disregard these rules, you will be receiving a letter to attend a Compliance Committee Hearing where fines may be implemented.




# **DID YOU KNOW?**

# **General Manager's Report**

The 2017 Summer Season at the lake has "come and gone". We are appreciative for the respect displayed this season where the common areas are concerned and on several occasions the watchful eyes of members that cautioned others about not leaving a mess on the Beach for example. We appreciate the compliments received about the cleanliness of the beaches this year. Frank conducted a very successful operation this year patrolling the lake. We had lots of compliments on Dee Dee and Frank for their friendly/helpful attitude. Just a late season note to Lake Swimmers: When you swim or allow others to swim out in the paths of coming boats, this is very dangerous!

Docks of the Bay are back on the Lake to complete the final dredging project for Lake Louisa. We have a map in the office that indicates where they dredged in 2016 and how many cubic yards was revoked from each of the coves and those remaining. Feel free to stop by and view that document. To date there has been 32,502 cu yds removed. You will be notified ASAP when having to move your boats from private/public slips to other locations while they dredge out these smaller coves.

Several questions have been posed to me, "why are they not dredging in closer to the Shore Line and my Boathouse?" The dredging permit issued by DEQ, prohibits dredging within ten feet of structures and seawalls.

Please do not clean out your yard/lot and place leaves and other debris in the roadway, right of way area in front of your property, or the drainage areas that lead to the Lake. Remember nothing can be placed in the Lake without Board permission.

Where winter prep is concerned, please remember to have those chimneys properly serviced and cleaned by a licensed professional prior to the wood burning season. Remember to check your smoke/fire alarms and change the batteries. It is a good idea to have your heat pumps and furnaces checked by a qualified company. Cooler weather is here, especially in the morning.

Parking on the roads or in the right-of-ways is prohibited and presents a danger to other drivers and those that walk. When you have larger gatherings @ your home please make sure that all attendees are observing this rule. This really presents a hazard during winter snow removal. Those not observing this will be referred to Compliance or in the event of the roads being blocked; the vehicle in question will be towed immediately.

RU has winterization tips in the office, should you need guidance. It is a good idea to exercise the valve in your meter by turning on/off during the year. Additionally all members should periodically check your water system for leaks, including a review of the meter. Call us if you need guidance on this.

We are very pleased to report that all 2017 Ridge Utilities water tests to date as prescribed by the Virginia Office of Drinking Water were submitted and approved.

Should you witness any activity that appears unlawful contact the Sheriff's Department immediately. Your identity will not be disclosed by them. The Sheriff's Department is currently assisting the community by monitoring the speed of vehicles on the roadways and has written some tickets.

The Association is offering a final limb pick-up for the year on November 6&7. Check the article for specifics in this edition.

Each member should have received notice of the Hickory Creek Bridge closing from October 9-20, 2017 for timber replacement. We will really try to make this painless as possible for all. Project is being done in house by our Maintenance Employees @ a savings of approximately \$60,000.00. Please call me if you have questions.
