## BAY AREA MORTUARY OFFERS FLAG CREMATIONS TO HONOR VETERANS

Bay Area Mortuary pays respect to military veterans by offering flag cremation with honorably discharged veterans.

Bay Area Mortuary announced today that they will be honoring two sources of American pride - our veterans and our flag. Bay Area Mortuary will be helping locaT residents retire American flags and honor veterans at the same time by cremating old American flags with honorably discharged military veterans.

The U.S. Flag Code states, "The American flag, when it is in such condition that it is no longer a fitting emblem for display, should be destroyed in a dignified way, preferably by burning".

John Sparrer, formerly with the U.S. Marine Corps Reserves and currently serving with the U.S. Coast Guard Auxiliary, owns Bay Area Mortuary, "Since you can't display or throw away flags that are faded, torn or tattered, we wanted to let people in the community know there is a way to retire their old flags and pay tribute to our fallen soldiers."

The Stars and Stripes are a symbol of our freedom and a reminder of the sweat, blood and tears that it took to build this country. Just like us all, the flag has a life-span and every flag should be decommissioned honorably.

The program offers veterans' families the option of having their loved one cremated with a donated, retired American flag. Bay Area Mortuary, in San Jose, is open for donations of tattered, stained or faded flags of any size for disposal in accordance with law, which designates that they be burned. "A lot of times flags end up in the trash or lying in somebody's closet somewhere," Bay Area Mortuary General Manager Andrew Sparrer said. "This is a nice way to honor both the flag and our veterans."

Families who opt to have a flag cremated with their loved one still have the option to take home a brand new American flag, just as with any traditional veteran's burial service.

Cremating a veteran with the American flag, the symbol that he or she fought for, is a way to honor those who have served our country not just on Memorial or Veterans Day but all year round.

To donate your old flag for a veteran, you can drop your flag off at Bay Area Mortuary Administrative Offices located at 2175 Stone Avenue. # **Defenders Lodge Guide**Palo Alto Division



#### Who can stay in the Defenders Lodge?

Defenders Lodge is designed to serve the following (reference statute 38 U.S.C 1708(b)):

- A Veteran with an appointment at VA Palo Alto receiving health care or a C&P examination.
- A member of the family or friend (referred to as Significant Other or (S.O.) who accompanies a Veteran to provide the equivalent of familial support.
- Veteran and S.O. are required to travel either 50 miles or more, or at least 2 hours from their home to the VA Palo Alto Health Care System, unless there are travel difficulties due to the health status of the Veteran, inclement weather, road conditions, or mode of transportation used by the Veteran (i.e. shuttle rider).
- Veteran and S.O.s who are physically stable, with no recent history of falls or gait instability.
- Veteran and S.O.s who are medically stable and manage their own medications and other medically related needs.
- Veteran and S.O.s who are psychiatrically stable with no acute symptoms for at least 30 days.
- Veteran and S.O.s who are free of drug & or alcohol problems for at least 30 days.
- Veteran and S.O.s who are capable of total self-care, or are accompanied by a caregiver.
- Veteran and S.O.s who are respectful of other people, with no history of threatening or assaultive behavior.

#### Significant others . . . Please note:

There are no provisions in the new law to lodge S.O.s that are not accompanying a Veteran for care. However, we will continue our current practice of placing S.O.s on a pending list.

#### **Pending List**

The pending reservation list is for guests approved to stay at the Defenders Lodge who do not have a reservation. Pending reservation listed guests must present themselves at the end of the day between 4:30 and 5 p.m. at the Defenders Lodge to be assigned a bed if space permits. Veterans are given priority for available beds.

•There is no guaranteed bed for those on the pending reservation list\*

#### How do I apply for Defenders Lodge?

Your doctor, nurse or other health care provider who is familiar with your health care needs will refer you by means of an electronic consult (Hometel) request.

#### **Room Accommodations:**

Rooms have two beds, so you will have to share the room with a roommate if you don't require a caregiver. Also, please be respectful and courteous of other Defenders Lodge guests and your roommate.

# When do I check-in & check-out if approved to stay in the Defenders Lodge?

- Defenders Lodge check-out hours are at 9a.m.
- Guests must arrive to check-in between 11 a.m. and 5 p.m. on non holiday

weekdays and between 2 p.m. - 4 p.m. on weekends and holidays.

- Approval for late arrivals will be given ONLY in cases of emergent circumstances or due to late plane arrivals. Late arrivals are allowed only up until 6:30 p.m. AND WITH PRIOR APPROVAL.
- After-hours check-in must go to the Administrative Officer of the Day located in Building 100, 1st Floor, Room A1 -134.

#### What do I bring?

- · Your usual medications that are self-administered.
- Personal hygiene articles and clothing
- Meals are not provided. Bring cash in case you need extra food, bus fare, etc.
- Alarm clock
- Earplugs
- EXTRA PILLOWS AND BLANKETS. Only one pillow and one blanket is allowed per quest.
- Food, drinks (NON-ALCOHOLIC) and utensils. These items will not be provided.
   There is a community microwave and refrigerator on site as well as vending machines.

#### Who is eligible for meals?

Only the following people are eligible for meals: Veterans undergoing radiation or chemotherapy, Veterans who permanently reside in Alaska or Hawaii, Veterans plus one S.O. who are being referred under Tri-Care contract and one meal for Veterans who are not allowed to eat or drink prior to a procedure.

Please Note: Defenders Lodge, the VA or its staffer volunteers are not responsible for any lost or stolen personal property.

#### How long can I stay in the Defender's Lodge?

Veterans undergoing extensive treatment or procedures, such as an organ transplant or chemotherapy are eligible for temporary lodging for the duration of the episode of care.

Lodging will be available the night BEFORE the day of the scheduled care, if the Veteran leaving home by 8 a.m. would be unable to arrive at the health care facility by the time of the scheduled care.

Lodging will be available the night of the scheduled care if, after the completion of the care, the Veteran would be unable to return home by 7 p.m. If Veteran or S.O. becomes medically unstable, or experiences an emergency, he/ she will report to the ER or call 911. Veteran or S.O. will not resume staying in Defenders Lodge until medically cleared by a physician.

#### Restrictions

- No smoking in the rooms and in or near the building. You are to smoke in the
  designated smoking areas only. If you violate this policy, you face a possible federal
  fine (ticket) and you will be asked to leave the Defencers Lodge. You will also be
  restricted for six months.
- You cannot store your medications in the community refrigerator.
- No alcoholic beverages or illicit drugs No firearms or weapons
- No personal items such as hotplates, coffeemakers, stereos, boom boxes, etc.
- No pets. Only approved service dogs allowed.
- No guests under the age of 18
