Following closing date, entries are **\$25.00**

Weekend **GRACH Special: \$50.00-All 3 Levels** for the **same dog/same trial - Pre-Entry Only.**

Junior Handler entries are \$12.00 Day of Show JR \$15.00

Entries will run in "B" if no designation is indicated.
