ORDINANCE NO. 2016-6

AN ORDINANCE OF THE CITY OF SPRING BRANCH, TEXAS ADOPTING THE COMAL COUNTY FIRE CODE IN THE CITY OF SPRING BRANCH

WHEREAS, the City of Spring Branch desires to put in place a Fire Code that is in the best interest of Public Safety: and

WHEREAS, the Comal County Fire Code is established and proven.

NOW, THERFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SPRING BRANCH, TEXAS, THAT:

The City of Spring Branch, Texas hereby adopts the Comal County Fire Code in and for the City of Spring Branch. If the Comal County Commissioners Court amends, revises, or replaces the Comal County Fire Code, City Commission shall pass an ordinance, order rule or resolution adopting the amended revised or replaced Comal County Fire Code in City of Spring Branch within thirty (30) days after the Commissioners Court takes its action.

ORDINANCE NO. 2016-7

AN ORDINANCE OF THE CITY OF SPRING BRANCH, TEXAS GRANTING AUTHORITY, RIGHTS AND PRIVILEGES TO THE COMAL COUNTY FIRE MARSHAL AND TO ACT IN THE CAPACITY OF FIRE MARSHAL ON BEHALF OF THE CITY OF SPRING BRANCH.

WHEREAS, the City of Spring Branch and Comal County have determined it would be mutually advantageous for the County to enforce the Comal County Fire Code within the municipal boundaries of Spring Branch; and

WHEREAS, the County is authorized to provide these services by Section 233.061 (b), Texas Local Government Code; and

WHEREAS, Chapter 791, Texas Government Code allows for an Interlocal Agreement between Comal County and the City of Spring Branch

NOW, THERFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SPRING BRANCH, TEXAS, THAT:

The City of Spring Branch, Texas hereby authorizes and grants to the Fire Marshal of Comal County, the same powers, rights and privileges that the Fire Marshal would have as a dedicated department of the City. Despite this authority, employees of the Office of the Fire Marshal are not employees of the City and work solely for the County.

ORDINANCE NO. 2016-8

AN ORDINANCE OF THE CITY OF SPRING BRANCH ADOPTING AND LEVYING AD VALOREM TAXES FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF SPRING BRANCH, TEXAS, FOR THE FISCAL YEAR 2016-2017; PROVIDING FOR AND APPORTIONING EACH LEVY FOR MUNICIPAL PURPOSES; AND PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN THE SAME SHALL BECOME DELINQUENT IF NOT PAID

WHEREAS, the members of the City Commission of the City of Spring Branch are of the opinion that it is in the best interests of the citizens of the City to adopt, establish and levy an ad valorem tax for the purpose of supporting the municipal government of the City; and

WHEREAS, it is necessary that an ordinance be passed levying an ad valorem tax on all real property within the corporate limits of the City of Spring Branch, Texas in accordance with the Texas Tax Code.

NOW, THERFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SPRING BRANCH, TEXAS, THAT:

Section 1. There is hereby levied and there shall be collected for the use, support and operation of the municipal government of the City of Spring Branch on all real property within the corporate limits of the City subject to taxation, a tax of \$0.12 for each \$100.00 valuation of property, said tax being so levied and apportioned for the current expenses, maintenance and operation of the general government (General Fund).

Section 2. Taxes levied under this ordinance shall be due October 1, 2016 and if not paid on or before January 31, 2017 shall immediately become delinquent.

Section 3. Taxes shall become a lien upon the property against which assessed, and the Comal County Tax Assessor, as the assessor and collector of taxes for the City of Spring Branch, is authorized to enforce the collection of such taxes, and shall, fix and establish a lien by levying upon such property for the payment of said taxes, penalty and interest. All delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law.
