### 2022 Refund Policy

Deposits are **NON-REFUNDABLE** (\$125) unless a **WRITTEN** request to cancel registration is received or postmarked within 72 hours from the registration date.

#### A REGISTRATION FEE REFUND WILL BE PROGRATED AS FOLLOWS:

A full refund, minus, the initial Non-refundable deposit (which covers administrative fees\*) will be issued only if the participant withdraws prior to the first day of practice (July 25, 2022)

#### NO REFUNDS

- O WILL BE GIVEN AFTER THE FIRST DAY OF PRACTICE.
- WILL BE GIVEN ON ANY FUNDRAISING MONEY OR BUYOUTS.
- WILL BE GIVEN ON ANY UNIFORMS \*CHEER AND FOOTBALL\*
- O W<mark>I</mark>LL BE GIVEN UNLESS ALL ISSUED GEAR IS RETURNED.
- Following the end of the conditioning period, request for refunds will only be considered for MEDICAL REASONS WITH DOCTORS NOTE. A written letter by your physician and/or a signed physical statement must accompany the refund request letter.
- There will be a \$35.00 NSF fee assessed for any returned checks. If the amount of the returned check plus the NSF fee is not paid to TYFC within 5 days of notification, the participant will lose his/her eligibility within the association and/or will be suspended from participation until total amount due is paid in cash or money order.

- Document preparation, processing, handling, copying, securing, and notification.
- Additional rostering, weigh-ins, Insurance and Assessment by SDYFC.
- Purchase of football jersey with individually sized and personalized with player's name.
- Other fees assessed by San Diego County Youth Football and Cheer Organization.
- Fundraising monies not collected.
- Academic ineligibility.
