INFO: Glynn Visual Arts (GVA) invites creative artists and crafters to participate in this festive holiday-themed event, located on beautiful St. Simons Island, GA, in the Pier Village. Talented artists working in a wide variety of mediums will be featured, along with kid's activities, entertainment, a visit from Santa and our third annual yarn bombing. This celebration provides an entire weekend of holiday festivities in an island atmosphere. This is a prime opportunity for shoppers to buy wonderful handmade gifts for everyone on their list!

ART: All pieces must be hand crafted by the artist. **Resale or wholesale items (buy/sell) are not permitted and will result in immediate dismissal without refund.** No manufactured, imported items, or raw materials are allowed. Artists may only show and sell work from the category in which they have been accepted. This is a family event, and any work deemed unsuitable by GVA will be removed from the show. No refunds will be given.

ARTIST: The artist must arrive on time and stay for the duration of the festival. Artists may not open their booth late or close early. No agents, dealers, or representatives may attend in place of the artist. Only the artist may display in a booth unless the work produced is a collaboration of two artists. Only partners in business signing all work with one name may exhibit together.

Artist BOOTH FEE: \$210 (includes electricity).

Food Vendor Booth Fee: \$245 (includes electricity)

No refunds will be made after acceptance for any reason.

CHECK-IN, SET-UP, AND BREAKDOWN: Check-in will begin at 10 AM Friday. Exhibitor booths must be ready for business no later than 10 AM on Saturday and Sunday. Break down or removal of any part of an exhibit is not allowed before 5 PM Sunday. Vehicles are not permitted in the festival area during the festival hours.

SALES: Artists are solely responsible for collecting, reporting, and submitting payment to the Georgia Department of Revenue, Sales, and Use Tax Division.

BOOTH SPACE: Spaces will accommodate a 10 ft x 10 ft tent. Artists/vendors must furnish their own tent (white is preferred), display tables, skirting, chairs, lighting, extension cords, and all display items needed. Displays must be designed, constructed, and operated in good taste. All displays, sales, and promotional activities must be confined to artist's assigned space. Electricity is available throughout the park, and all exhibitors are encouraged to light their displays in a festive manner. Power cords, however, must not cross walkways.

SECURITY: Overnight security will be provided by the Glynn County Police Department Friday & Saturday. Exhibitors are encouraged, however, to take all small and/or valuable items out of their tents during the times the festival is closed. Glynn County, Glynn Visual Arts staff, committee, and volunteers are not liable for lost, stolen, or damaged items.
