PROSPECTIVE BOARD MEMBER RON YAMATO

University at Los Angeles, where he obtained a BS in business while also working for the US Postal Service. He later became a Postal Inspector, performing criminal investigations and forensic audits. The entire trimming of the crab apples and crape myrtles has been completed and we are looking forward to a beautiful spring and summer bloom season. SAFETY AND WELFARE NOTES

On Tuesday, April 17th, at 10 a.m., we will conduct an **earthquake drill** in Chantarelle. We had postponed our annual drill, usually held in October, as a result of the fires at that time. You will be given more information in the next newsletter, and a flyer with instructions will be sent out a week ahead of the drill. If you do not already have an orange "I'm OK" sign in your home, let me know and I'll give you one ahead of the drill.

We can still use more volunteers

for the drill, as well as for the Safety/Welfare committee in general.

Daylight Saving Time begins at 2 a.m. on Sunday, March 11th. In addition to remembering to "spring ahead" with watches and clocks, this is a good time to check batteries in smoke alarms and CO alarms.

To minimize disruption to sleep patters during this transition, here are a few tips from sleeplady.com:

- Go to bed 15 minutes earlier than usual on the Thursday before DST begins.
- · On Friday go to bed 30 minutes earlier than usual.
- On Saturday try to go to bed 45 minutes earlier than your usual bedtime.
- Eliminate all caffeine after 1:30 p.m. this week in order to make it easier to go to bed earlier.
- · If possible, also avoid alcohol this weekend, which negatively affects sleep.
