## The Owner Agrees:

To make all arrangements for the periodic shoeing/trimming of the horse/s and assume all cost hereof. A \$5 per horse charge for handling horse if owner is not present.

Horse/s must receive all recommended shots for the area twice a year or once a year, depending on recommended schedule. Proof of such vaccines and current worming record are to accompany horse/s at the time of their arrival to the facility and be maintained for inspection while the agreement is in effect.

Facility shall have full rights to ownership of the horse/s in the event owner fails to pay boarding fees, veterinarian fees and or farrier fees within 30 days of due date. Facility shall have the right to dispose of the horse/s for it's full market value to recover the debts, legal costs, labor costs and any other costs associated with recovering debt.

<sup>\*</sup> If you opt to clean your own stall, it must be done on a daily basis. If stall is not cleaned by 8pm each day, we will clean it for you and charge \$5 for every day we must do the cleaning.

Owner shall not hold facility agents, manager or employees liable for any damages or injuries to the horse/s, owner or guests of owner.

Owner is responsible for, financially and to repair, any damaged caused by their horse. If horse is destructive, it is the Owner's responsibility to mitigate the destructive behavior.

All riders given permission by owner to ride their horse/s must display to facility written permission to do so by the owner and all persons using this facility must have a Release/Waiver on file.
