Only artists juried in as Exhibiting Members are eligible to exhibit in WITVA member shows.
Applicants must be current associate members in good standing.
Please carefully read through all the information to begin your process.
Judging is held 3 times a year - November, January and March. The exact day, time and location can be found on our WITVA website.*

Getting ready

Send an email to JuryWITVA@gmail.com to let us know you will be coming to our next jurying day. Include:

- Name, address, phone numbers and email address*
- Bio/resume explaining your art experience*
- For 2D, Photography/Digital, and Jewelry/Fiber - Jpeg images of 6 of your original artworks, including the 3 you will bring to the jury (please indicate the size and medium)*
- For 3-D/ Sculpture - Jpeg images of 6 of your original artworks, including the one you will bring to the jury (please indicate the size and medium of 3-D work)*

Criteria considered by our jurors

- Consistency of the body of work (all pieces should be of a similar style)*
- Composition/use of space*
- Color/values*
- Technical skill (expertise with the medium)*
- Presentation (paintings and photography must have appropriate framing or finished gallery wrapped sides and must be ready to hang with d-rings and wire)*

For jurying day bring

- 1. Filled out WITVA Jury Application (below)*
- 2. \$20 Check for the jury (The check is nonrefundable and is to be made out to WITVA Inc.)*
- 3. Artwork:
For 2D/Photography/Jewelry/Fiber – 3 original artworks for each category applying
For 3-D/Sculpture – one original artwork
Label artwork with your name, email address, phone number, title, medium and size*

Please note that you have half an hour to set up your artwork in the jury room before you have to leave so the jury can start. Pick up is the same day one and a half hours after the drop off.

bring the required amount of artworks for each category)

- Two dimensional (painting, mixed media, printmaking)
- Three-dimensional sculpture
- Photography
- Jewelry / Wearables (fine arts only, no crafts)

Rules for jurying: Any applicant applying for artist membership must be an artist in one of the visual fine arts, but not limited to: painting, mixed media, photography, sculpture, jewelry. No crafts are acceptable. The artist member applicant must be juried by WITVA to be eligible to exhibit in WITVA members shows. The applicant must submit a BIO and a resume explaining their art experience. Attach a \$20 check with the application completely filled out. The check is nonrefundable and is to be made out to WITVA Inc. You will be notified by email of the decision by the jury committee. If you are declined, you may reapply. The jury would like to help and will give constructive criticism and make suggestions for reapplying. If you do not show up or notify WITVA before the jury date agreed upon you will be unable to reapply for one year. Be sure to bring the required items on the day of jurying.
