ASI Water Project Moves Forward Tower Construction Begins

Improvements on the Amana Colonies water system began this week with prep work for the new water tower. Water line replacement will begin in a week (pending weather) between Amana and Middle Amana.

It's expected that the water line replacements in Middle Amana, High Amana and West Amana will get underway in the spring, however the schedule is still being determined, explained Russ Eimers of the Amana Society Service, Co.

The project moves forward because the Iowa Department of Natural Resources has completed its final review and issued construction permits.

The \$5.6 million project designed by Howard R. Green for the Amana Society, Inc. will replace aging water lines and old water towers, improve water delivery and water quality.

The water project has been in the works for about two years, so ground breaking is good news for Amana water customers. Those who attended the July 2017 public meeting about the project at the Amana Colonies RV Park will recall that the improvement project is necessary to replace aging water towers, water lines and water wells. Improving water quality and improving water pressure are two goals of the project.

Water quality has been an issue in High Amana and West Amana where the Service Co. is currently treating the water to keep lead and cooper levels below EPA standards. Samples are taken on a regular basis in accordance with all EPA requirements, Eimer noted. Water pressure has been an issue in High, West and in East Amana. The low water pressure becomes more evident during water main flushes, Eimer explained, but may be noticeable to some customers. This project is designed to resolve those issues.

Also good news is the funding that Amana Society Service Co. was able to secure with the help of the Iowa DNR.

Amana Society Service Co, which owns and manages the water system in the seven villages, has pursued a federally subsidized loan to pay for over 70% of the estimated \$5,603,000 cost of the project. The lowa DNR has approved the project for inclusion in that federal, low-interest loan program which is designed to help rural water systems make necessary upgrades.

As Eimers explained, the low-interest loan will allow the Amana Service Co. to provide safe drinking water at as low a cost as possible. The remainder of the project cost will be financed by the Service Co.

As was explained in July, three wells will be dug near the current High Amana well. There will also be three new wells south of 220th Trail and just west of the Whirlpool facility in Middle Amana.

Two older wells, one near the Amana water tower and one near the Amana Colonies Golf course will be reserved for backup, but the old wells in West Amana, High Amana, Amana, and East Amana will be abandoned, according to Iowa DNR rules, after the new wells have been put into service. Ricklefs Excavating from Anamosa, Iowa has contracted to construct the wells and lav pipe with Cahov Pump Service, from Sumner, Iowa diaging the wells. The new tower will be located on the hilltop west of Middle Amana along what is commonly known as the "hog barn road." As noted above the tower construction is expected to begin in early March, weather permitting. The new tower will be about 160 feet tall and hold 250,000 gallons of water. The contractor selected for the project is McGuire Iron, the same company that built the water tower last summer near Conroy. The new tower will be erected, painted and put into service this year, Eimers explained. The last phase of the project will be to take down the old water towers in West Amana, High Amana, Middle Amana, Amana and East Amana. Removal of the old towers will not start until 2019 after the new central tower is in place and operating as expected, Eimers said. The water tank and water system on the south side of the Iowa River serving South Amana and Homestead are currently under evaluation as the Amana Service Co. looks at all options for improving service and delivery while replacing the aging, underground water tank in Upper South Amana or perhaps connecting the Homestead and South Amana water systems, Eimers said.

Be Alert for Utility Phone Scam

The Amana Woolen Mill was contacted last week by someone claiming to represent the Amana Society Service Co. The Woolen Mill staff person was told to supply their credit card information immediately to prevent their electricity from being turned off.

The Amana woolen mill staff quickly identified this as an obvious scam and took the appropriate action. They hung up and called the Amana Society Service Co.

Russ Eimers, Amana Society Service Co., urges everyone to be aware that a utility company will never contact you by phone to ask that you make immediate payment over the phone. If this happens to you. Hang up and contact the utility company.

Eimers explained that should your payment be late, the Amana Society Service Company will contact via mail, then they may call you. They will indentify themselves by name, explain exactly how much is overdue and give a customer several days to make payment.

Also before any service is shut off, the customer will be posted (notified in writing) and given time to make payment.

Eimers noted, "We deliver it to the customer door ourselves and I think Alliant does too. After the posting, we must give the customer 48 hours to respond, either to pay in full or make arrangements for a payment schedule, before we may shut them off. These steps are in accordance with the Iowa Utility Board rules."

To repeat, if you get a call demanding payment and threatening to shut off your gas, water, electricity or telephone service, hang up and call your utility yourself to report the call.

FEATHERS IN THE WIND

I believe it was when my class was in eighth grade that Mrs. Franey would give us this list of approximately twenty questions we were to answer using the encyclopedia.

Usually we got this list towards the end of the week which was not a good thing if you did not have a set of encyclopedias at home to use. Frankly who did in those days?

Using the one set we had in the classroom meant waiting for someone to get through with whatever book YOU needed. This involved patience, something that few people who are in their early teens or, for that matter, any age has much of.

It was "decided" by some parent that if a group of parents all bought sets of these books the price would decrease.

Can you just imagine how thrilled the encyclopedia salesman was to have this "windfall" come his way? The commission must have made him be able to pay the mortgage for the month.

I keep referring to the person who sold these books as men because I do not recall any woman, selling things door to door except for "Avon" products.

The only question I really remember was who was referred to as, "first in war, first in peace, first in the hearts of his countrymen."

Currently, it would be easy to punch in that question on one's computer or "Smart Phone" and get the answer.

Even in our age (try the 1960's) Mrs. Ruff would have referred us to using "Bartlett's Quotations," but that was then and we did not have that book on hand either. I suppose we could have wandered into the high school library, but that was something none of us had the nerve to do.

I know that I would do all these questions on Saturday mornings which (I felt) could be used for better things.

The encyclopedias came in blue, red and (the most expensive) white. I have never figured out why that white color cost more, nor did I really care because most of us got the blue encyclopedias.

I do remember that the cost was over a \$100.. a large sum in those days. Okay it still is a lot of money for books until you consider that in the early 1970's the average cost of a book was about \$17. (I am going to assume they were figuring in the cost of text books at the time.)

The other thing was that paperbacks could be bought at less than 50 cents.

I still remember the "Tab Book Club" we had in school. Our poor teachers had to make a list of the books we ordered, send off for them and then distribute those wonderful smelling (yes, I did say, "smell') books to their eager readers.

I often wonder why Mr. Berger did not just lose his mind doing that because we were so determined to get our books first and would push and shove until we did get them. (Who ever said that they not little heathens?)

Cleaning out my father's house I once again came across the encyclopedias which I am sure my parents saved up for. I marvelled at how much we treasured them.

There were certain people who would literally read the books like novels devouring each entry and even memorizing them. I am sort of sorry that those books have fallen by the wayside and are no longer being used. It was sort of fun finding the answers to those questions and then reading on and finding out more about the person, event or whatever that was asked about.


It certainly was a great pleasure if one could answer all the questions and then hand in one's paper the next Monday with great pride.
