Trial Information: Trial statistics and other pertinent information will be posted at www.k-9sports.com.

B MATCH: We're having a B Match on Saturday afternoon one half hour following the last class of the day. \$5 per run. Toys are ok but no food in the rings. Get some extra ring time on your dogs! Dogs do not need to be entered in the regular trials. Dogs may be entered multiple times in the same class with a maximum of 4 runs per dog.

Move-ups: The deadline to send in your move-up is Monday, Oct 3, 2016 at 6:00 pm. Move-ups must be submitted in writing (email ok).

Height Cards/Measuring: We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 26" dogs. We will have a measuring official available to measure dogs from 7:30 am to 8:30 am and various times throughout the day.

Start Time & Running Order: Check in and measuring time will begin at 8:00 am on both days, with first dog on the line at 9:00 am. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

Off Leash Areas: Dogs will be allowed off-leash in designated areas only. Retractable leashes will not be allowed at this trial. **And PLEASE pick up after your dogs.**

Parking: We ask if you are crating in the building that you leave the up front parking area for those that are crating in their cars. Day parking is on a first come, first served basis. Please park in designated parking spaces only. Do not block building entrances or fire lanes.

Crating: There will be crating space inside the stall area. You may need to share your stall with others as space is somewhat limited. You may arrive for crating set-up after 4:00 pm Friday.

Food: The Overlake Collie Club will be providing lunch for workers. Workers will receive a coupon they can turn in for lunch. All others we ask for a \$5 donation. We will also have a worker raffle that you can use these coupons at.
