

<u>SAFETY:</u> An item of blaze orange clothing must be worn by field marshals, bird planters, handlers, gunners, judges. and all members of the gallery.


WWESSC will have blaze orange vests available for guests to borrow. Smoking is not allowed while in the field. Smoking is permitted in the parking area.
