Ken Blank thanked all those who worked during the recent cold spell and thanked Station 3 red shift for assistance on a recent call.

The names of those required to file Economic Interest Statements has been filed with the County Clerk.

The report of injuries for 2018 has been posted.

ASSISTANT CHIEF CAMPBELL'S REPORT

Pierce is in the process of completing the repairs to the pump. The UL pump test has passed. The truck will then be sent out for undercoating and will be scheduled to be shipped back to Mokena.

Ambulance 94 (International) went to Chandler Services due to replacing the injector harness that shortened out. The ambulance was out of service for approximately one week.

HOH Water Technology performed a routine valve rebuild, which included replacing the lower pistons and seals, in the water softener at Station 3. The cost for the repairs was \$1,375.00.

The overhead door at Station 3 was out of service due to the cable failing. Scott Overhead door replaced the cable and performed general maintenance on the door.

A group purchase for medical gloves was done between Mokena FPD, Homer FPD and Manhattan FPD, resulting in a savings for Mokena FPD of approximately \$300.00.

In preparation for the extreme cold conditions, an incident action plan (IAP) was created to ensure the overall safety to our customer and the members of the Mokena FPD. This plan was shared with the Board. Thank you to the Chief for his leadership and to all the crews during this time.

ASSISTANT CHIEF CIRELLI'S REPORT

The dual-band pagers have been placed into service and are working well. These pagers allow alerting on either VHF or 800 mhz.

A/C Cirelli attended the Homer Glen Public Services and Safety committee meeting on February 6, where the importance of being prepared ahead of the polar vortex was discussed. Because Mokena FPD was pro-active and issued an IAP we did not have any issues with frozen pumps on the apparatus.

We currently have two employees out on reported duty-related injuries.

The Annual Compliance Report has been completed and submitted to the Center for Public Safety Excellence. Thank you to Accreditation/ISO manager Adam Shefcik for completing this task.

A/C Cirelli reviewed some of the updates to the Standard of Coverage document. The entire document will be emailed to the Board for review and approval at the March Trustee meeting.

CHIEF'S REPORT

The FY2019 ambulance billing data was reviewed.

The Board has no objection to purchasing two plaques that memorialize the names and years of service of all the past, present and future Trustees and all past, present and future Fire Commissioners.

The Mokena FPD is collecting items for local veterans, as well as veterans at the Manteno Veterans Home. A list of needed items was posted on Twitter, Facebook and our website. We will collect items and bring over to William Martin VFW Post #725.

We have received our annual TIF District funds in the amount of \$238.00.

Lt. Joe Shefcik notified the District that he will be retiring after 21 years and 4 months of full-time service to the District. His final shift date will be the end of July 2019.

Chief Stephens recently met with representatives from the BP Tank Farm. They would like to add a secondary pump, additional exterior road, additional manifold for Mokena FPD to access, would like to tie in to water from the Village of Orland Park and purchase an additional 5000 gallons of foam.
