Karla Lampe – Swan Estates – I just seen on the agenda that you guys were going to discuss multi-family sewer charges.

Voorhis – Ms. Lampe, at this time we're on the public hearing for the hearing. I believe what you are talking about is on the agenda for after the hearing is done and then we will have another public forum.

Lampe – Ok.

Voorhis – Just to update everyone as I didn't before. Mr. Steve Short spoke about the rate increase. To give everybody an update, the residential rate increase, we're looking at going up to \$28.80 for a base rate, \$7.10 for a usage charge for the residential. On the commercial side of it, we're looking at going to \$30.80 for the base rate for the service charge and \$7.10 for the usage charge.

Frankling Hodges – Can I ask a question?

Voorhis – We have open forum Mr. Hodges to talk about...

Hodges – The sewer? I have a question. It would be on Steve here. I forget what my sewer bill is. It's probably \$32 a month or something like that, how much more a month are you talking that it's going to jump to?

Voorhis – Mr. Hodges...

Hodges – Do you know?

Voorhis – If you're in the city of Fair Grove, you pay a base rate now of \$21.80 as a base rate and you pay \$4.80 per 1,000 gallons of usage. Quick math would say, you said your bill is \$32?

Hodges – I use about 2,000 gallons or so a month. It's not really 100% accurate cause my son is filling up water tanks and stuff and watering stuff in Springfield, trees and stuff so how much would that bill be?

Voorhis – I can't give you an exact estimate Mr. Hodges but I can give you an estimate on that. \$20.80 that's a \$7.60 jump from the current so an additional \$7.00 plus another \$3.00, Mrs. Petty did some quick math, it's around \$43 so about \$10 to \$11.

Hodges – I was just curious cause there's a lot of people here in Fair Grove that can't afford a lot but my opinion, like I said, when you addressed the sewer problems and things, I don't think some of the stuff is real accurate like was said at the last meeting. The water that's going through there, I don't think that you're treating the water, if that's really going through there as Mr. Icenhower was saying, you're not treating it, it's just going right straight through.

Icenhower – No, it's not going straight through. It's all got to go through the plant.

Hodges – I know it's going to go through the plant but the sewer can't handle, I think you said 10 or 15 million more gallons or something. You ain't treating no 10 or 15 million gallons. It's not getting cleaned.

Icenhower – Oh, it is getting cleaned.

Hodges – I don't think so.

Icenhower – Well it is. It all has to go through the plant...

Hodges – I know, I know. Going through the plant...

Icenhower – It don't make any difference.

Voorhis – Alright.

Hodges – I'm gonna address that later on.

Voorhis – When we go into public forum you can come up and talk. We will have to continue this public forum for another 5 minutes as we have to keep it open for 15 minutes for people to have the opportunity to speak on the public hearing.

Petty – When will this reflect on people's bills?

Davis – I believe April is what has been discussed.

Petty – With the new average?

Davis – Yes.

Let me explain why I support the proposed sanitary sewer increase for residential users customer charge of \$28.80 and volume charge of \$5.80 per 1,000 gallons with five percent increases the following three years. I apologize to the Aldermen for the rehash of facts but also direct this to folks who have not had time to study our situation.

Historically we had two professional reviews of our sewer system with both suggesting increasing the rates to adequately fund and operate the enterprise. Most recently the SANITARY SEWER RATE STUDY prepared for the City of Fair Grove prepared by OWN Engineering as presented on the Fair Grove Internet page. Basically, the report states the treatment plant has sufficient capacity to effectively treat domestic waste water through 2034 assuming "the majority of I&I will be eliminated". The report further states the average residential sewer volume is 3,400 gallons which was confirmed by the review of actual October, 2024 billing records. To meet the suggested operation and facility improvements the OWN report suggested a residential customer charge of \$36.71 and volume charge of \$7.20.1

The Facility Report prepared by Trekk Design Group, LLC concludes the in depth review that included inspecting the treatment plant and lift stations, inspecting and documenting every sewer manhole in the system, testing every line, and smoke testing about half the collection system during dry weather (the whole system was not smoke tested due to a lack of MoDNR grant funds). After documenting I&I with flow monitors located in key manholes, smoke testing observations, and facility records Trekk Design group suggested rate increases were needed to meet operating and capital improvement plans.²

Our neighbors ask "why should I pay more for sewer"? Nearly everyone does not want a rate increase. No one wants to pay more for their utilities than someone in a neighboring community. That is human nature. Fair Grove has documented in two studies that improvements must be made and they cannot be implemented out of current revenues. Rates have to go higher so improvements can be completed. While our rates will go higher than those in some nearby communities, that is a temporary situation as other cities address their improvement needs.

Neighbors ask "is our sewer rate affordable, will we be paying too much"? Rate reviewers and states use an Affordability Index to determine if the monthly residential sewer charge for 5,000 gallons is affordable. This is calculated by dividing the cost of 5,000 gallons divided by the median household income as provided by the US Census Bureau. The current (2022 data) median annual household income for Fair Grove is \$71,447.³ The proposed \$28.80 customer charge plus volume charge for 5,000 gallons equals \$57.80. \$57.80 divided by the monthly median household income (\$5,954) equals and affordability index (\$5,954 x 2%=\$119.08) \$57.80 / \$119.08 equals an affordability index of 0.49. An Affordability Index of 0.49 is generally considered a "cheap" sewer utility charge.

The proposed increase may increase sewer revenue by \$10,500 monthly.⁴ Since this is significantly less than engineering studies suggested leadership must allocate wisely.

We are stewards of the precious land and water resources that are entrusted to us. Our land and water are not just natural resources; they are the lifeblood of our community. Protecting these vital assets is essential for our current and future generations. Todays and our childrens health and welfare depend on Aldermen Stewart, Icenhower, Roe, Petty, Veach, and Lord.
