

DCM Moises called the meeting to order at 9:36am, and we opened with the **Declaration of Unity**. Sixteen persons were present, representing ten groups, nine voting members (sign-in follows). JD read the Checklist for Tradition Twelve; Heather read the Concept Twelve Checklist. The Agenda was approved with addition of discussion re website, Hotline and Christmas Alcahthon.

Interim Secretary report: November meeting minutes approved. **SECRETARY STILL NEEDED FOR DISTRICT 6. !!!**

Treasurer's report: Alejandro distributed copies of the December Treasurer's Report, with a proposed 2012 Budget attached. Noted that two 2012 assemblies meet on the Big Island, travel more costly than 2011. Noted \$2,789 bank balance remaining from unspent 2011 budget allocations and April Assembly proceeds. District would need \$1,910 in Group donations in 2012 to meet Budget needs. Group donations in 2010 were \$2,249; in 2011 were \$2,655. After review, the **GSRs passed the 2012 District Budget.**
