Please remember that the speed limit on our streets is 25 mph. We have many children in our community and sometimes they ride bikes or scooters into the street. Please be mindful that a child or pet could run out at any time.

Pet owners: please do not let your pets out to do their business in other people's yards. If you take your dog for a walk please take bags with you and pick up their mess. The entranceway on Coy's Lane is not a free zone – please pick up pet mess if you use this area as well.

Sanitary Sewer Update:

I recently attended a LFUCG public meeting regarding the Remedial Measures Plan that LFUCG entered into with the EPA regarding the settled lawsuit from 2008 to eliminate sanitary sewer overflows. The Remedial Measures Plan is a 12year project estimated to cost \$600 million dollars and is made up of 82 projects in Lexington and Fayette County. Our neighborhood is not one that will be directly affected by the plan from a construction standpoint, as there are no projects in or near our community. However, there are 3 projects along Richmond Road, Idle Hour and Woodhill. Two of the projects will begin in the next month or so and are projected to be completed before the end of 2014. These projects will include construction in the Richmond Road area across from the old Lexington Mall location as well as on and under New Circle Road at Woodhill Shopping Center. The projects are to increase the size of the sanitary sewers and to add a collection tank to eliminate overflow during heavy precipitation periods.

Please be aware of the construction workers when driving in the work zones.
