### WE BELIEVE

- ❖ That Jesus Christ became the sinner's substitute before God, and died as a propitiatory sacrifice for the sins of the whole world.

In becoming a coworker with *CEF*<sup>®</sup>, and in order to protect the ministry, I agree not to propagate or practice in *CEF*<sup>®</sup> ministries any distinctive or controversial doctrines, methods, and practices that would go beyond the *CEF*<sup>®</sup> "Statement of Faith" and the approved *CEF*<sup>®</sup> curriculum.
