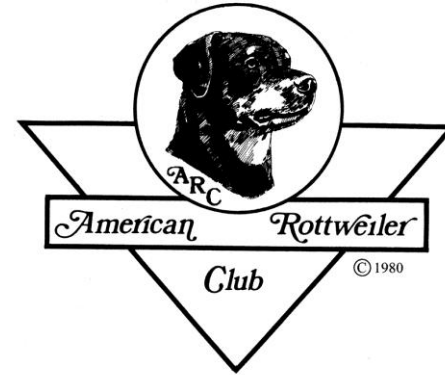

Awards

A qualifying score is required for all prizes.
Flat ribbons will also be offered for first through fourth in each class.
A prize will be awarded for FIRST place in each division.

A prize and rosette will be offered for: High in Test Rottweiler
A prize will be offered for: High in Test "Notweiler"

THE CLUB WILL NOT BE RESONPONSIBLE FOR MAILING ANY AWARDS OR SCORESHEETS.

Limited Entry

Entries limited to 20 total. A team will be considered a single entry for the purpose of counting entries. Test is open to all breeds, but ARC requires Rottweiler entries have priority. The test is closed when limit is reached and no refunds will be issued for cancellations after this time or after June 1st. We do not expect to reach limit.

Entries received after 6pm July 18, 2023 must include \$10 processing fee.

Note: If the event has to be cancelled due to Club concerns, all entry fees will be refunded in full.

AGREEMENT

I (we) agree that the club hosting this Test, has the right to refuse entry for any cause, which the club shall deem sufficient. I (we) understand that I (we) enter a dog(s) at this ARC Carting Test at my (our) own risk.

In consideration of the acceptance of this entry and of the holding of the event for which it is intended, I (we) agree to hold the Club, it's members, directors, officers, agents and the owner or lessor of the premises and any of the employees of the aforementioned parties, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog, whether such loss, disappearance, theft or injury, be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself, ourselves, or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused negligence of the aforementioned parties or any of their employees or agents, or any other persons.

\$25.00 return check fee will be charged on all returned checks.

I (we) acknowledge the ARC "American Carting Test Regulations" and the "AKC Obedience Regulations" are available to me (us), that I am (we are) familiar with their contents and that I (we) agree to abide by these regulations at this ARC Carting Test.

This is an ARC Sanctioned Carting Test.

ARC Carting titles earned are not AKC titles. The AKC allows Rottweilers to record the title on the registered name, for a fee, but this opportunity is not available to other breeds.

Entry Fees:

Single Entries: Entry \$30.00; \$20 for additional entry of same dog.

Team Entries: \$30 for team. Includes both dogs; \$20 for additional entry.

The team can be considered a second entry if one dog is entered in single.

\$15 DISCOUNT for any owner who enters 3 dogs at first entry price providing the entries are received at the same time and all dogs have one registered owner in common.

Pre-Entries Close: July 18, 2023 at 6pm or when entry limits are reached, whichever is first. If limit has not been reached, ENTRIES WILL BE ACCEPTED UP TO DAY OF SHOW (up to start of walk through) providing a \$10 processing fee per entry is paid.
