### King of the Hill Coronation Tournament Rules

1. The South Sound USBC Youth Certified King of the Hill Coronation Tournament is by invitation only. Bowlers must have qualified in one of the monthly tournaments held from October 2015 through February 2016.
2. USBC rules and regulations will govern the Coronation Tournament. USBC Youth Division Code will be enforced and will be certified (sanctioned). All bowlers must have a current South Sound USBC Youth card and be in good standing.
3. **Entry fee** will be \$20.00 (\$8.50 lineage/expenses, \$4.00 scholarship, \$7.50 prize fund) Scholarship will be through the SMART Program (Acct. #9009). Scholarship and trophies will be awarded on a 1:5 ratio or fraction thereof in each boys and girls division. Scholarship funds from monthly tournaments will be given out for the Coronation Tournament. All added scholarship will be pro-rated per division.
4. Division 1 – Boys & Girls will be SCRATCH. Division 2 through 5 – Boys & Girls will be handicapped at 100% of 210.
5. Divisions will be based on current 2015 – 16 averages and are as follows for Boys & Girls:

Division 1	170 & up SCRATCH
Division 2	150 & up Handicap
Division 3	126 – 149 Handicap
Division 4	101 – 125 Handicap
Division 5	100 & below Handicap
6. Bowler will compete in the division that they qualified in as a monthly winner. If a bowler won more than once, they will be in the highest division that they qualified in.
7. For Division 1 – Boys & Girls: A total of three (3) games **SCRATCH** will determine who advances to the step-ladder finals. Division 2 through 5 – Boys & Girls: a total of three (3) games plus *handicap* will determine who advances to the step-ladder finals.

8. If a division has (5) or more bowlers, the top five (5) will advance to the step-ladder finals. If a division has less than five (5) bowlers, then all participants will advance. **Step-ladder finals will be with handicap for divisions 2 - 5.** Finals will be bowled as follows: position #5 bowls position #4, winner bowls #3, winner bowls #2, and winner bowls #1 for championship match.
9. Bowlers' average will be based on the Wednesday prior to the tournament. Proof of average is required to bowl. **BRING LEAGUE STANDING SHEET OR HAVE COACH SEND IN VERIFICATION TO TOURNAMENT DIRECTOR.**
10. Dress attire must be neat, clean and proper fitting. Collared shirts, SSUSBC or USBC official youth jersey and slacks, Bermuda shorts, capris, skirts or skorts must be worn. Skirts and skorts must be to the end of fingers when arms held down to side. Tournament Director must approve any/all exceptions. Tournament Director's decision is final.
11. Any errors in scoring need to be brought to the Tournament Officials immediately. All other conflict with general playing rules must be made to the Tournament Director no later than 30 minutes after completion of the Tournament. Any protest must be confirmed in writing to the South Sound USBC Association within 72 hours. The Tournament Director will make all final decisions.
12. Bowlers arriving late shall begin play and score shall count beginning with the frame that is being bowled. Frames missed will be credited with a zero. A bowler not present and ready to bowl when it is his/her turn will be credited with a zero for that frame.
