From The Board:

Deed Restrictions & Architecture Control

A big thank you to the Architecture Control Committee (ACC) for their thoughtful review of applications in 2020! Please remember all exterior changes require a submittal for approval. This includes roof, fence or driveway replacements even if the resident believes the replacement is not a change. The application for ACC approval can be found can be found on the community website.

We all work together to preserve our community. The ACC ensures that exterior modifications comply with our deed restrictions. Our management company, Real Manage, helps enforce our deed restrictions by monitoring and reporting violations. As a homeowner, you too can report violations by contacting Real Manage or through your Real Manage portal account.

If a member is found to be in violation of our deed restrictions, the member will receive ample time to fix the violation. If, after sufficient notice, the member still has not fixed the violation, the Association will begin to impose a statutorily authorized fine of \$100 per month for as long as the violation remains outstanding. The Association can also take other alternative or subsequent actions, such as fixing the violation on its own accord (for example mowing a member's lawn that is in violation of the deed restrictions) or begin legal action.

Please help Country Village preserve its beauty which it has maintained for almost 50 years! Now, more than ever, as a new generation begins to fill the homes that the past generations worked so hard to maintain, we must all work together to keep our community at its best. With the re-paving of Kirkwood, the work of the Architectural Control Committee, and our members' continued compliance, Country Village should be welcoming its 50th year in all its glory!

Financial Activities

In alignment with our Bylaws (Section VI), an annual audit has been put in motion and is being performed by a licensed CPA. We are targeting to have the 2019 annual audit completed by August 2020. Kirkwood Lift Station Diversion and Abandonment update

The City of Houston is abandoning the existing sanitary sewer lift station on the east side of Kirkwood, south of the Buffalo Bayou Bridge by rerouting the sewers west to the Harvest Moon Lift Station near Dairy Ashford. Construction has now reached Lashbrook and will soon progress down Carriage Hill.

Kirkwood Paving and Drainage Project update

Phase 1 of the project to reconstruct Kirkwood Road from Buffalo Bayou through Briar Forest started on June 29th. The project will be done in 3 phases starting with the north bound lanes from Lakeside Place to Buffalo Bayou, then Lakeside Place to Briar Forest and finally the southbound lanes from Buffalo Bayou to Briar Forest. Completion date is December 2021. The project number is N-100029-0001-4. For General concerns call the City 3-1-1 (713/837-0311).
