PARKING DURING A SNOW EMERGENCY

A snow emergency will exist when the National Weather Service is predicting a snowfall of 3" or more in any period of 24 hours or less. During a snow emergency no vehicle shall be parked on any street or public way; **EXCEPT** in the downtown business district defined in 8-1-8(g) and any vehicle over 10,000 pounds on the East side of Gillette St. in the 300/400 blocks per Village signage. SNOW REMOVAL

Don't forget that you must clear the snow/ice from your sidewalk within 24 hours after the snow has stopped. **Snow/ice should not be pushed or blown onto the street.**

If there is a fire hydrant in the right-of-way on your property, please remove the snow around it. This is for your safety and the safety of your neighbors in case of a fire emergency this winter.

IF YOU HAVE A MAILBOX

The Village of Pardeeville **WILL NOT BE RESPONSIBLE** for mailbox damage caused by the plowing of snow (force of pushing snow).

UTILITY CORNER

Utility bills are mailed on the last working day of the month and due the 20th (or next business day if a weekend.) It is your responsibility to keep your account information up to date!

If you do not receive your bill, please call the office and we can get you a total or another copy. Failure to pay **by the due date** will result in a penalty and past due notice being generated.

If you are moving in, please contact the office to get a service application. If you are moving out contact the utility department to schedule a final reading and bill sent to your new address.

CROSS CONNECTIONS

All residences are required to have an inspection every 10 years. If you haven't had one and would like to schedule yours please contact the utility office at 608-429-3054. These take approximately 30 minutes and someone must be home.

Available times are Monday, Tuesday and Thursday between 7:30-3:00 p.m.

GARBAGE/RECYCLING

Garbage/Recycling pick-up is every Friday *except* when a holiday falls on a Friday. We will post the dates of collection when this happens on our website and in the newsletter.

Residents must supply their own containers (cannot be from another collection company - they will not be picked-up) and items **MUST** be placed to the curb by 7 a.m. to ensure pick-up. Garbage is limited to 6 bags per household. Recycling can be co-mingled; cardboard should be broken down and separate. Recycling should be in a clear plastic bag or bin/tote you supply.

Garbage must be kept separate from recycling

Please place garbage and recycling bags/containers on a flat surface and **NOT** in the snow banks.

During extreme weather conditions, pick-up times may be adjusted. Reminder that bags/cans must be placed on a flat surface; items placed in a snowbank or frozen to the ground cannot be picked up.

Keep an eye out for information on the possibility of moving to the supplied garbage/recycling carts.

RIGHT-OF-WAY PERMIT

The Village has recently enacted a right of way permit for any work being done in the right of way. If you are unsure if a permit is needed please call first! You can obtain this form on the website or at the Village Office and the fee is \$150 for most work.

ELECTIONS & VOTER REGISTRATION

If you need to vote by absentee ballot or register, you may apply at the Village Office or by visiting myvote.wi.gov. You must have proof of residence: driver's license, utility bill, bank statement, government document etc. that has your current street address on it to register and a photo id to vote.

If your address has changed you must re-register with the correct address! Any questions please contact the office!

LICENSE YOUR PET(S)

Dog and cat licenses are required annually per State Stats. and village ordinance. You must bring in proof of rabies vaccination from your veterinarian's office (this must include date of vaccination, tag # and manufacturer of vaccine; not your receipt of services). Licenses are due by April 1, 2020 or a late fee will apply! Failure to license your pet could result in a fine of \$218.50.

License Fees: Spayed/neutered dog or cat \$5.00. Unaltered dog or cat \$10.00. You can drop off your rabies certificates with payment and a self-addressed stamped envelope and we will mail your tags if you cannot make it to the office during open hours.

Contact the clerk with questions or concerns.

BUILDING PERMITS

Please check the Village website or call the office before starting any building project to see if a permit is needed. Permits are needed for fences, sheds, plumbing, electrical work, new furnace, additions, structure changes etc. **Permit fees will be doubled if you start a project without a permit.**

Please allow 10 working days to obtain permit and fees are increasing for 2020.
