**EXHIBIT LOCATION AND DATE** Walker County Agricultural Center, 10052 Hwy 27 N, Rock Spring, GA 30739.

**Friday, Nov. 10 th,** 6:00 PM - 9:00 PM: Exhibitors Move In

**Saturday, Nov. 11 th,** 8:00 AM - 4:00 PM: Crafters Day

**Saturday, Nov. 11 th,** 4:00 PM - 6:00 PM: Move Out

Please have your exhibit ready by 7:30 AM. Parking will be limited, please park in the upper parking lot after unloading anything on Saturday Morning.

Concessions will be available in the kitchen area. Biscuits, Soups/beef stew, sandwiches, and other fine items will be available.

**EXHIBIT RESTRICTIONS** All exhibits must be county fair based. All materials sold or demonstrated must be **handmade or homegrown**. Other exhibits may be educationally based. All exhibits must fall under the Battlefield Farmers' Market guidelines otherwise approval must be made through the Board of the Battlefield Farmers' Market at (706) 764-6923 for contract approval.

**FLOOR PLAN** Most exhibits will be located indoors, if you want a specific location, please state this on your contract, (returning exhibitors have first choice). However, we will work with you as much as possible.

**LIABILITY** The exhibitor must surrender space occupied by him in the same condition as it was at the commencement of occupation. The exhibitor shall assume all responsibility for damage to the exhibit facility by reason of his exhibit and shall indemnify and hold harmless the exhibit facility, BFM, and their representatives for all liability which might ensue from any cause whatsoever arising out of the exhibitor's participation in the exhibits or in festival activities. The exhibit facility, BFM, and their representatives will not be liable for injuries to any person or for damage to property owned or controlled by the exhibitor, which claims for damage or injuries may be incident to, arise from, or be in any way connected with the exhibitor's occupation of display space, and the exhibitor, on signing the contract, expressly releases and indemnifies the aforementioned from any and all claims for such loss, damage or injury.

**CANCELLATION** Exhibitors who request cancellation of this contract may be relieved of their contract; however application fee is non-refundable.

**EXHIBITOR APPLICATION FEE** of \$35 per booth/date will benefit the continuance of the Battlefield Farmers' Market .

**GENERAL REGULATIONS** Exhibits must be staffed during exhibit hours by persons who are well prepared to explain, courteously and effectively, all products and services on display.

**LIMITATIONS** All exhibits, demonstrations, and distribution of materials shall be confined exclusively to the assigned space. Each exhibitor is responsible for keeping the aisle or aisles near his booth free of congestion resulting from his demonstrations or other promotion.

**LIGHTING** if you need any additional lighting you will need to come prepared with your own extra lighting.

**REMINDER** This Crafters Day is primarily for the promotion of the Battlefield Farmers' Market. It is a crafters day focused on the celebration of the agriculture and family based materials in our area. Please do not promote or sell any items that have not been handmade or homegrown. The BFM reserve the right to cancel any contract and ask you to forfeit your booth. Please keep this as a celebration of the arts in our area.
