Epidermoid Cysts – Sandie Frame

Epidermoid (or also called epidermal) cysts are bumps under the skin's surface that are sometimes inflamed and painful. They form when skin cells shed and collect under the skin instead of sluffing off. As they grow, they fill with keratin – a protein material. Although they can look red or dark, these cysts are usually not infected. Although you might be tempted to squeeze the cyst or drain it on your own, do not. The cyst can rupture and be harder to treat in the long term.

Epidermal cysts do not go away on their own, but they may become smaller over time, even without treatment. However, if your cyst grows, ruptures, becomes painful or appears infected, have it checked by your healthcare team. The most effective treatment for inflamed cysts is to first allow the inflammation to calm down, and then remove the cyst wall and its contents.

Surgical removal of the cyst involves making an incision and then releasing the cyst and cyst wall from surrounding tissue. Your skin may then be stitched shut. A medical professional will first inject a local anesthetic to numb the area and make sure you are comfortable. The removed tissue might be sent to a lab to make sure it is not cancerous.

After the procedure, you may have restrictions such as avoiding strenuous activity until the stitches are removed or until the incision has healed. Surgical removal typically cures the cyst. But if the cyst ruptures or is drained without completely removing the cyst wall, part of the cyst may remain, and the cyst may come back.

As an alternative to surgical removal, injecting a steroid directly into the skin over the cyst can sometimes reduce inflammation and provide relief. Antibiotics usually are not needed unless an active infection is confirmed. Very rarely, an incisions and drainage may be performed to relieve pressure in the short term but this will not remove the cyst wall.
