**ACKNOWLEDGEMENT OF RISKS, ASSUMPTION OF RISK AND
RESPONSIBILITY AND RELEASE OF LIABILITY**

WARNING: There are significant elements of risk associated with ranch or rodeo activities, as exposure to or handling of machinery inspection, inspection of cattle, riding of horses, mules, burros, bulls, sheep, calves, or other type of animal; or management of animal drawn vehicles. Most of which activities, are conducted under stressful conditions and uneven ground. Ranch and/or rodeo event are dangerous and have significant, inherent risk of injury and/or death. The animals used in rodeo events are dangerous and unpredictable.

ACKNOWLEDGEMENT OF RISKS: I recognize that there are inherent dangers associated with travel or by activities carried on in the presence of livestock. Such hazards may include, but not be limited to, the following: (1) Uneven, unstable, or slippery ground or road surfaces; manmade or natural objects in, upon, or overhanging the ground. (2) Inclement weather, including thunder and lightning, variances and severity of wind, temperature, and weather conditions. (3) The presence of motorized and non-motorized vehicles, people, other horses and riders. (4) Movement, noise, and contact with objects with may frighten or cause an animal to rear, buck, bolt, run, or otherwise move unpredictably and with force.

EXPRESS ASSUMPTIONS OF RISK AND RESPONSIBILITY: I assume the risks of personal injury, accidents and/or illnesses, including but not limited to sprains, torn muscle and/or ligaments; fractured or broken bones; eye damage; cuts, wounds, scrapes, abrasions, and/or contusions; dehydration; oxygen shortage (anoxia); head, neck and/or spinal injuries; animal or insect bite; allergic reactions; shock, paralysis, and/or death. I also acknowledge that if during the activity I/we experience fatigue, chill and/or dizziness, my/our reaction time may be diminished and the risk of an accident increase.

COVENANT OF GOOD FAITH: I recognize that LRRR, as provider of goods and/or services, will operate under a covenant of good faith and fair dealing, but that LRRR may find it necessary to terminate an activity due to force of nature, medical necessities or other problems; and may terminate or refuse to terminate the participation of any person LRRR judges to be incapable of meeting the rigors or requirement of participating in the activity. I accept LRRR's right to take such actions for the safety of myself and/or other participants.

AUTHORIZATION: I hereby authorize any medical treatment deemed necessary in the event of any injury while participating in the activity. I either have appropriate insurance or, in its absence, I agree to pay all costs of medical services that may be incurred on my/our behalf.

RELEASE: In consideration of services or property provided, I myself, and any minor children for which I am a parent, legal guardian or otherwise responsible; as well as any heirs, personal representatives or assigns, do hereby release Li'l Rough Riders Association, LLC and Tulsa RV Ranch, its principals, directors, officers, agents, employees and volunteers and each and every land owner, municipal and/or governmental agency upon whose property an activity is conducted, from all liability and waive any claim for damage arising from any cause whatsoever.
