***Representing Public Figures and Negotiating Contracts for Ohio New Lawyer Training***

This seminar gives a concise and informative overlook of what it means to practice entertainment law, specifically as it relates to representing public figures in contract negotiations. WildWetT.com* will be used as a case study when discussing the importance of protecting one's image and likeness, and how to prevent against misappropriation using Ohio Revised Code Section 2741. Atwood, et al.* will be discussed to illustrate the versatility an entertainment lawyer may need to have when clients behavior turns criminal.
