RESOLUTION NO.: SL - 40 - 2023

TITLE: Approval of Contract with the University of Nevada Reno for Fisheries Management Program Assistance

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation ("Reservation") and to the long-term protection, preservation, and management of these resources; and

WHEREAS, the Summit Lake Paiute Tribe currently administers a Bureau of Indian Affairs (BIA) grant (A22AV00034/Fund 164) for the Fisheries Management Program at the Reservation; and

WHEREAS, the Summit Lake Paiute Tribe and the University of Nevada Reno (UNR) have previously worked together on the Fisheries Management Program; and

WHEREAS, UNR has graduate students with the skills to assist with Fisheries Management Program tasks and has provided a contract and statement of work that meets the specified budget; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering into an Agreement with UNR.


BE IT FURTHER RESOLVED that the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute the agreement with UNR and any other instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
