## For Immediate Release:

On December 20, 2016, at 8:19pm, Officer Kyle Ferreira was dispatched to the Stop and Shop Store, 327 Franklin Avenue for a report of a shoplifter in custody by loss prevention officers. Upon his arrival, the subsequent investigation led to the arrest of Richard M Zulla, Rio Grande, age; 28. He was charged with shoplifting. He was transported to the Bergen County Jail in default of \$2500.00 bail as well as two active warrants from other jurisdictions. He is scheduled to appear in court. Officer Terrence Murphy assisted.
