# OCER Lifetime Achievement Award

Presented to

Jim Baldwin, DVM - AERC# 7205

Jim vetted AERC rides for over 28 years. His 1<sup>st</sup> ride to vet was Old Dominion sometime in the 1980s and he continued to vet AERC rides even after he turned 80 in 2018. He competed in endurance for 20 years beginning in 1990 with his 1<sup>st</sup> ride being Cougar Prowl on Bug's Will. He completed 117 rides (ten 100s) and accumulated 5300 Endurance miles and 675 Limited Distance miles with 10 Best Conditions. He joined the AERC Board in 1992 and served on the board through 2004. He served on multiple AERC committees, many for multiple years until 2005 to include the Vet Committee, the Protest and Grievance Committee, the Trails Committee, and the Competition Committee. He completed his 1st Tevis ride in 1995. He and the infamous Goose finished at 128<sup>th</sup> place in 21:48 hours. 196 started, 129 finished. Jim began vetting Tevis in 1997 and vetted it 17 times! His accomplishments are many and his contributions to endurance are innumerable!

In recognition of his unwavering dedication to the sport of endurance and longtime support of the ride managers and members of OCER, we gratefully present Dr. Jim Baldwin with the 1st OCER Lifetime Achievement Award.

# President's Letter

I wanted to thank the OCER membership for their faith in placing me in the office of President. I'll do my best for the club.

If anyone has any suggestions or ideas about OCER and things you'd like to see the club do (or not do), please let me know. The Franks, Emma McKinnon and Cathie Birmingham have had clinics in the recent past to encourage new riders. Anyone else interested in hosting a clinic?

I know generally there is concern about the lack of ride entries. I wasn't a participant in the "heyday" of endurance. I know Louise Burton speaks of rides with 90 riders. Part of the problem now is the expense, in my opinion. Gas/diesel, and ride fees are expensive for riders; the ride managers struggle to have a ride break even due to lack of entries.

I attended both of the Weather Rides in February. Each of these rides has minimal volunteers, and only one vet. The format of these rides has been changed to be more DIY for the rider. Riders need to check their horse's heart rate, and enter their in and out time onto a public board.

Riders also bring the awards. The ride fees are kept to a minimum. It may be that more rides will need to take on this type of format in order to reduce costs. Ride managers need to know what we as riders want to have at the rides.

I know locations are also more difficult to find.

Monica Chapman recently invited Michael Maul, Michael Campbell, Paul Sidio, Tommy Robicheaux and me on a conference call to discuss the lack of rides and ridership in the Central Region.

During the conference call, Michael Maul said we could sort the member list in AERC by zip code so that we could locate members close to a particular ride. We discussed contacting these members about volunteering for that ride, helping to assist with the trails in advance, or managing a ride.

If you have any ideas, please let me know – by phone, email, private message on Facebook, or at any of the rides. Likewise, if you have any concerns, please let me know. All of us want to be able to continue participating in the rides.

WE NEED RAIN, SO WE ARE HOSTING A RAIN DANCE RIDE. COME OUT AND DANCE ON OUR TRAILS TO BRING THE RAIN AND PUT SOME HOOF PRINTS DOWN ON OUR NEW TRAIL.

LOCATION: 430799 EAST 220 ROAD, VINITA, OKLAHOMA

COORDINATES: 36° 41' 53"N, 95° 19' 37"W

**DIRECTIONS:** FROM THE EAST AND VINITA TAKE HWY 60/66 WEST FOR APPROXIMATELY 4 MILES. TAKE A RIGHT FOLLOWING HWY 60 WEST TOWARD NOWATA. AFTER 5.8, AT THE TOP OF THE HILL TURN RIGHT ONTO 4310 RD (GRAVEL ROAD) FOR 1.7 MILES. TURN LEFT ONTO 220 ROAD, THE RANCH IS ON THE LEFT.

FROM THE SOUTH, USE I44 OR HWY 69 TO GET TO BIG CABIN, OKLAHOMA, CONTINUE ON HWY 69 UNTIL THE T INTERSECTION WITH HWY 60, 66 AND 69. TURN LEFT ONTO HWY 60, AFTER APPROXIMATELY 1.3 MILES STAY TO THE RIGHT FOLLOWING HWY 60 TOWARD NOWATA. AFTER 5.8, AT THE TOP OF THE HILL TURN RIGHT ONTO 4310 RD (GRAVEL ROAD) FOR 1.7 MILES. TURN LEFT ONTO 220 ROAD, THE RANCH IS ON THE LEFT.

FROM THE WEST FOLLOW HWY 60 EAST FROM NOWATA, OKLAHOMA, APPROXIMATELY 17.8 MILES. TURN LEFT ONTO 4310 RD (GRAVEL ROAD) FOR 1.7 MILES. TURN LEFT ONTO 220 ROAD, THE RANCH IS ON THE LEFT.

OKLAHOMA STATE LAW REQUIRES ORIGINAL NEGATIVE COGGINS PAPERS DATED WITHIN 12 MONTHS OF THE RIDE TO BE PRESENTED ON ALL EQUINES IN CAMP. HEALTH PAPERS DATED WITHIN 30 DAYS OF THE RIDE MUST BE PRESENTED ON ALL OUT OF STATE EQUINES.

**TRAILS**: THE TERRAIN IS GENTLE ROLLING HILLS AND THE TRAILS RUN THROUGH PRIVATE RANCH PASTURE AND CREEKS. THERE WILL BE CREEK CROSSINGS, DEER, ARMADILLOS AND A STRETCH OF COUNTY ROAD ON THE NEW TRAIL. PONDS AND STREAMS ON TRAIL PROVIDE PLENTY OF WATER.

**CAMP**: PRIVATE PASTURE LAND, PRIMITIVE CAMPING WITH PORT-A-POTTIES, HORSE WATER AVAILABLE AT THE VET CHECK AREA.

**Junior Riders**: Any rider under the age of 15 as of December 2019 must be accompanied by an adult sponsor throughout the ride. A helmet is also required while mounted. If the junior has no sponsor before the ride, please contact management and often a sponsor can be arranged.

**Introductory Ride**: The purpose of the 8 mile introductory ride is to give a new rider or equine a chance to experience the sport of endurance. The equine must be at least 48 months old but there is no age limit on the rider. There will be a standard vet exam. The non AERC member fee does not apply.

**Pre-Registration**: You **must** pre-register or let Alanna know you are intending on riding. We can accommodate 25 rider and the first 25 entries will have a spot on the trail and in the camp.

Riders are welcome to arrive before Friday, but please contact ride management with intended arrival date.

#### **Ride Rules:**

- 1. AERC and OCER rules will be enforced. Rules can be found at <a href="https://www.aerc.org">www.aerc.org</a>.
- 2. The equines are under the control of experienced ride veterinarians who will do everything possible to help you evaluate your equine in order that you may complete the ride without hurting your equine; However, you must accept responsibility for your equine and yourself. The vets may disqualify any rider who has, in the opinion of the vets, abused his/her equine. The veterinarian's decision will be final in all matters concerning the safety and well being of the equines entered in the ride.
- 3. The ride is open to all breeds of equines (horses, mules, ponies, etc.). The equine must be at least 60 months of age to enter the 50 ride. Equines entering the 25 mile limited distance ride must be at least 48 months of age.
- 4. All riders must be present and accounted for at the start of the ride. Management *strongly* recommends ALL riders wear approved safety helmets while on horseback.
- 5. The same horse and rider must pass all checkpoints, follow the ride rules, stay on the marked trail and do the loops in the correct order to receive completion. 50-mile placing will be determined by first horse across the finish line. ALL equines must see a Vet for completion check or when pulling for any reason.
- 6. Vet criteria (pulse/respiration requirements, holds, etc.) will be discussed at the pre-ride meeting. Riders are responsible for understanding this information. All equines in each distance MUST meet ride criteria within 30 minutes of reaching a vet check during the ride or be disqualified.
- 7. There is no minimum time limit for completion in any distance. Maximum ride time, INCLUDING HOLDS, for completion is 12 hours for 50 milers and 6 hours for 25 milers. To receive completion: the 50 mile rider may present his equine at any time during, but not longer than, one hour after crossing the finish line; 25 milers must present within 30 minutes of reaching camp and ride time does not stop until equine has met ride criteria. The equine of all distances must be metabolically fit to continue and have no gait aberrations that are consistently observable at a trot and must have a pulse of 64 or less; pulse of 60 or less for 25 milers. Riders will dismount for completion trot. For Best Condition judging, equines must present for a 15-minute CRI, then a one hour post-ride check 15 minute CRI time measured from the finishing time. To be eligible for Best Condition Award, riders must weigh before leaving vet check area.
- 8. Riders are responsible for all farrier and vet fees that may be individually incurred.
- 9. During the ride, dogs are to be on a leash or confined to rider's camp.
- 10. Have a Fun and SAFE ride. "To Finish Is To Win"

Dogs on leash are welcome. **Remember, for ecological maintenance concerns: Pack it in, Pack it out.** 

All breeds and genders of equines are welcome and encouraged. Equines must be at least 48 months of age to enter the limited distance ride and at least 60 months of age to enter the endurance ride. The trail is nicely mowed, fairly flat, but does have areas with rocks. Foot protection is recommended. All veterinarian (vet) checks are in camp. There is water in camp so there is no need for you to haul water to the vet examination area.

Start: the 50-mile ride will start at 7:00 AM, and the 25/30-mile ride will start at 7:30 AM. The Introductory ride will start after all the 25s have gone.
