Careful thought and prayer has gone into this decision. We will have VBS August 3rd—5th, however it will look very different.



2020 SCHOLARSHIP INFORMATION...

The Scholarship Committee of First Presbyterian Church is pleased to announce the availability of a limited number of scholarships for our church community. To be eligible for a scholarship, the candidate must be an active member of First Presbyterian Church of Bismarck, or must be an active participant in the life of an under resourced PC(USA) church for at least three years. These scholarships can be used for any level of study beyond high school. Maximum eligibility for scholarships is four years; those years do not have to be consecutive. Graduate students are eligible for these scholarships provided that the four-year maximum has not been reached. Applications are available in the Narthex or for download form the front page of the church website at www.fpcbismarck.com. The application deadline is June 15th, 2020.



CHILD CARE CENTER...

May was Child Care Provider recognition month. In recognition of all the Child Care Center staff, Director and Assistant Director, we, as Board Members of the FPCCC thank each and every one of you for putting your health on the line during this pandemic. We appreciate your dedication, compassion and caring affection towards the children. We just want to say THANK YOU for being you and ESSENTIAL CAREGIVERS FOR OUR CHILDREN: GOD BLESS-CHILD CARE BOARD MEMBERS.

This Memorial weekend we want to give a huge thank you to all the health, safety, frontline and essential workers during this pandemic, with a special prayer to those who have lost a friend, family member or coworker, during this time.

Since mid-March, the Child Care Center has been operating according to the *Modified Operating Practices* set forth by the North Dakota Department of Health. A few of these practices are as follows: daily health screening for all staff and children. This involves each person answering a series of health-related questions and having their temperature check every morning, along with monitoring temperatures throughout the day. After the temperature checks and questions, everyone is required to go directly to the restroom to carefully wash their hands; this does include infants! Stagger use of areas such as the playground and break room. Group sizes no more than 10 individuals, which does include both staff, as well as children in the room.

Also, during this time, the FPCCC has been participating in the Child Care Emergency Operating Grant (CEOG). This grant was developed to assist child care programs to remain open and provide care for children of healthy, safety, frontline and essential workers, during the COVID-19 pandemic. The CEOG payments are based on our licensed capacity, rather than on the current number of children on-site during the week.

As one can likely imagine, throughout these past couple of months, enrollment at the Center has been much lower than normal because many families have been instructed to work from home. Again, this grant helps to make that job-change less of a financial burden for families by allowing them to pay a modest monthly holding fee to keep their child's spot secure. Initially, well over one-half of our enrolled families took advantage of the monthly holding fee. Now, however, as more parents are returning to work, we are slowly increasing in numbers. Currently, we are operating at approximately 48 percent of our normal enrollment. This will likely remain consistent for a couple more months.

While things at the FPCCC have been quieter due to fewer children, we are busy trying to maintain a sense of normalcy for our young children. Staff members are working hard at providing quality care and creating a safe and secure environment for the children. Spirits remain high and laughter fills the classrooms. However, we would encourage you to keep us in your prayers; these are unusual times and we would appreciate being covered by your prayers. God Bless!

NURSE'S NOTES...

Happy June Everyone. I hope you are all safe and healthy. This has been a very challenging couple of months. All of our lives have been affected by this COVID-19. We must be patient and follow the CDC guidelines to protect ourselves and others. We will get through this together. Unfortunately, even the most dishonest individuals are preying on those who have been affected by COVID-19. Below is a copy of North Dakota Senior Medicare Patrol Scam of the month. Reports are coming in on how people are trying to scam our public during the COVID-19 pandemic.

ND SMP SCAM OF THE MONTH—MAY 2020 Frauds Related to COVID-19

The economy may be shut down, but business is booming in the fraud arena. The country is finding themselves at war with fraudsters. Following are just a few of the current frauds related to the COVID-19 pandemic:


- COVID-19 Prevention Pill and Cure: This scam solicits investments in a company that pushes pills and cures, claiming they can cure patients within two to three days. A scammer posted a video on an Instagram account showing himself taking the pill and then walking into an area with COVID-infected individuals stating that he would not get the virus.
- Coronavirus Medical Kit: Operators of a fraud scheme, as published on their website, offered consumers access to World Health Organization (WHO) vaccine kits in exchange for a shipping charge of \$4.95, which consumers paid by entering credit card information on the website. Understandably, Americans are desperate to find solutions to keep their families safe and healthy. Fraudsters are seeking to profit from fear and uncertainty by defrauding consumers and committing identity theft.
- **Virus Pesticide:** A company claimed that it could reduce the risk of COVID-19 infections in public spaces with the new generation of fungicide which reduces transmissions by 90%. Upon investigation, it was found that the fungicide was being imported from Japan and was illegal to distribute in the U.S.
- COVID-19/Genetic Testing: A company marketing medically unnecessary genetic testing schemes saw the pandemic as an opportunity to expand on the existing scam, capitalizing on people's fears and using the national emergency for financial gain. The tests were bundled with expensive respiratory pathogen panels with the company receiving kickbacks on a per-test basis. The company marketed the hard to obtain COVID-19 tests, conspiring to bilk citizens of a valuable resource that was in high demand by the medical community.
- **Reporting Medicare Fraud:** If you think you have spotted fraud, report it right away. ND SMP will help seniors prevent, detect and report Medicare fraud. If you see anything suspicious, contact the ND SMP at ndsmp@minotstateu.edu or call 1-800-233-1737 or 701-858-3580. for non-Medicare fraud issues, contact the ND Attorney General's Office at 1-800-472-2600.

Session Highlights

SESSION HIGHLIGHTS MAY 19, 2020

CLERK'S REPORT

There were no membership changes; total membership is 355.

FINANCIAL REPORT

Total Income YTD Actual	\$238,780	Budget \$165,073
Total Expense YTD Actual	\$200,606	Budget \$202,297
NET Income	\$ 38,175	Budget -\$ 37,224
Unrestricted General Fund	\$187.792	-

Total income reflects the addition of the SBA Payroll Protection loan/grant of \$56,782 which has been placed in a restricted fund to be used for payroll.

MODERATOR'S REPORT

Pastor Leanne thanked the staff for their diligence and flexibility during the past months. A sub-committee on protocols for reopening is being formed. Online worship will still continue when services are held in the Sanctuary.

COMMITTEE REPORTS (from Committee minutes)

Administrative and Personnel—Committee recommended additional security cameras to oversee west parking lot and discussed protocols for restarting church services.

Business and Finance—Eide Bailly will conduct an audit the week of July 13. Committee reviewed the HVAC report and recommended the financial plan be approved by Session.

Christian Education—Adult Bible studies continue via Zoom. Graduating seniors will be honored. Committee discussed possible methods for VBS.

Membership—The committee has called church members.

Mission/Outreach—Masks are being made and given to Bismarck Cancer Center. Due date for church scholarships was extended to June 15.

Property and Equipment—HVAC subcommittee reported on the engineering recommendations. A three-phase approach will be recommended to Session.

Worship and Music—Session approved purchasing a two-months supply of individual communion packets. Committee will propose a contract with Josh Stokka for his technical services.

Child Care Center Board—About 20 children are enrolled at this time. Families who had enrolled children pay \$50.00 per month to hold their place if they are not sending a child at this time. Grants from the ND Dept. of Human Services are being received along with the SBA loan/grant of \$96,118.50.

Session Highlights

NEW BUSINESS

Session approved the proposed financial plan and recommendations of the HVAC subcommittee and Business and Finance Committee. Phase I represents the most urgent needs and would provide the greatest benefits. Included in Phase I: upgrade centralized system controls to a direct digital control; upgrade terminal unit controls to low voltage; replace air cooled chiller including concrete pad; modify ductwork and install reheat coils for offices and conference room; engineering design and contingency. Cost estimate for Phase I is \$335,600. Phase II and III include replacement/repair of air handlers, replacing boilers and other heating work. Total estimate for the three phases is \$917,560. There is no timetable for Phase II and III. Bids for Phase I work would be accepted this summer.

Session approved obtaining quotes from banks on interest rates for loan. Church loans also need the approval of the Presbytery. A capital campaign would begin in 2021.

Session approved the payment of \$27,000 to Prairie Engineering for engineering services, to be paid with existing church funds.
