### Terms and Conditions of Sale

- Only horses which are registered with a breed association shall be consigned to the MN 50/50 Sale.
- Weanlings consigned must be registered in the member's name, or that of an immediate family member. The original papers must be present for the foal to be sold.
- In the event of a NSF check, the foal will be returned to the consignor. The foal may retain its eligibility in the MN 50/50 Futurity if the consignor pays the MN 50/50 50% of the foal sale price or 50% of the average foal sale prices from that year's sale, whichever is less.
- Foals may be substituted up until the day of the sale, as long as there has been a foal consigned and cataloged previously in the sale. (Coggins must accompany the substitute foal and health certificate.)
- All horses should be fit to the best of their potential. They should be healthy, exhibiting high body scores and having a good hair coat.
- All selling positions will be assigned to each foal, and the horses will be sold in catalog order.
- Each member will be assigned stalls for foals.
- Members may consign up to four foals as voted upon by membership.

\*As a consignor, I am a paid member in good standing of the Minnesota 50/50 Futurity & Sale. I recognize that the MN 50/50 and R & J Sale Barn are only acting to provide a time and place for the sale of my horse. By consigning my foal to this sale, I recognize that this horse will be eligible to compete in the MN 50/50 Futurity as a two year old in 2024. I recognize that any disputes are between me, as the seller, and the purchaser, as determined by the auctioneer. Neither R & J Sale Barn nor the Minnesota 50/50 membership has any obligation, duty, or liability to me with respect to performance or non-performance by any purchaser. I, as consignor of a horse or horses, agree to be bound by and abide by all the forgoing terms and conditions.
