Streets: Going back out to mow. Hopefully paving is done before fall festival. Have to get on ditches. Got the ditch at Saddle Club and Main done. Said it looks real good.

Mayor asks about street repair. Got Magen done. Crystal Cove is hopefully going to be started on next week. One of the pipes has issues. Roe asks about Magen where the dead end is if they are paving it. Danderson says they are doing all of it.

FINANCIAL STATEMENT

Mayor says that we got our ARPA funds. Brown says that we got bonus money around \$1,400 from the remaining ARPA funds that other cities did not want. The report shows all cash accounts. Took in \$101,000 and spent \$88,000. It's early in the year, everything is looking good. We did pay \$16,000 for our bond principal. We are in the middle of doing gWorks. Once it is finished, we will bring reports to the board. They are still getting Quickbooks reports until gWorks is up and ready to go. Brown will be back tomorrow to try to get more work done on gWorks. Brown asks about the contract for the auditors. Icenhower asks about how long the contract is for. I explained it is only for this audit. He is not impressed with the auditors we have. He doesn't see how spending 2 hours out here is a complete audit. It takes longer for his personal audit. Larry says he cannot say that the City will get a good audit. It was probably better for them to do the audit this year. It took a lot of Sara and Brooklyn's time. They send a list to be copied and take a backup of Quickbooks with them. Darra says she is not involved in the audit. She has seen audits for the City where people were here 2 or 3 days. Decker and DeGood are only here for hours. Icenhower says he thinks it's something that needs to be looked at next year. Roe agrees.

PARK BOARD

Krystal Hughes says there isn't a lot going on. July is slow. They are starting soccer. They are doing fall soccer but since their numbers are so low, the people who run soccer will take less money than they would in the spring. There are some kids that play soccer and no other sports. Since this is the only sport that goes twice a year, in the spring the kids get trophies and in the fall they will get ribbons. Flag football will start in September. They had more kids for football than they did for soccer. Cheerleading is also offered for football. Mayor asks how many vacancies the Park Board has and Hughes states 2. There is someone interested but she hasn't turned in her application yet.

EMERGENCY MANAGEMENT

Sgt. Bridges says there isn't much to report right now. Learning job and contacts. The old office is cleaned out. Everything is in her office at the police station. Danderson asks how much of the stuff is junk. Bridges says there are boxes of stuff. Danderson says toss anything that isn't needed. Bridges suggests putting the coloring books at the fall festival. Lord asks about the Grant. Bridges says she has a contact on the Grant keeping her updated. The training for the Grant is the priority. We need to make sure she has what she needs. Danderson asks if the contact information has been changed on the Grant. Bridges stated there was a paper she needed signed. Clerk had Mayor sign the paper and got it to Sgt. Bridges.
