Our Antiracist Work

After receiving a request from Black movement leaders for a letter of support from Jewish organizations, we were proud that more than 44 sections including SE Atlantic, and NCJW Inc. <u>signed on to this letter</u> joining 500+ Jewish organizations and synagogues to say that black lives matter! Thank you. This letter also raised some questions from NCJW leaders about how to respond to concerns about Black Lives Matter and BDS. <u>Please check out Sheila's email response to these questions</u> that was shared on the Executive Director, Section President, and State Policy Advocates listsery.

Additionally, we are working with NCJW's board on a plan of commitments around our work addressing systemic racism in response to this important <u>open letter</u> to Jewish organizations written by Black Jews and non-Black Jews of color (which was co-written by NCJW San Francisco board director Lindsey Newman!). Our first commitment will be providing the board, staff, and NCJW leadership antiracist trainings. We will update you soon when these are available.

Banana Sour Cream Bread

2/3 cup butter or margarine, softened

1 1/3 cups sugar

1 teaspoon baking powder

1 1/2 teaspoon salt

1 1/2 cups mashed bananas, (about 2-3)

Mini chocolate chips optional

2-3/4 cups sifted flour

1 teaspoon baking soda,

2 eggs

1/2 cup sour cream

1 cup chopped walnuts

Preheat oven to **350** degrees. Cream butter and sugar until light and fluffy.

Add eggs and mashed bananas.

In a separate bowl, sift the flour, baking powder, baking soda and salt together.

Add the dry ingredients alternately with the sour cream to the banana mixture.

Stir in the walnuts and optional mini chocolate chips

Pour into two greased 9 x 5 x3- Inch loaf pans.

Bake 45-50 minutes. Let cool, then remove from pans.

Freezes well. Yield: 2 loaves.

Note: Flavor improves If allowed to stand overnight.

- * obtaining consent to phone residents, check in, and share holiday information and holiday memories
- * providing personalized holiday greeting cards along with a small holiday gift
- * offering activity directors a modified version or our holiday script
- * creating a video Zoom recording of our HOW program for the facility

I'm sure there are more ideas to consider. I would greatly appreciate input from our members as to how we can make the Holiday on Wheels appropriate, meaningful, and manageable as we prepare ourselves and our community for a Rosh Hashanah unlike any other.

Update on Advocacy

This has been a very exciting month for the courts. The Supreme Court issued three rulings that were awaited with much trepidation. First, the court ruled that President Trump may not dismantle DACA, ruling on procedural grounds. Chief justice John Roberts wrote the majority opinion.

Second, the court ruled clearly to outlaw employment discrimination against LGBTQ people, upholding Title XII of the civil rights act of 1964 in a 6-3 decision.

And, most recently, the court struck down a Louisiana law requiring all doctors performing abortions to have admitting privileges at a local hospital. This case was almost identical to one in Texas that the court struck down as unconstitutional in 2016. It was a 5-4 decision and was the first such case after the addition of Neil Gorsuch and Brett Kavanaugh to the court.

We must not get complacent and need to keep the pressure on our legislators to protect access to necessary health care, including reproductive care and abortions.

Last month Judge Hinkle ruled on the issue of convicted felons being able to vote. The state of Florida had failed to fulfill its obligation regarding SB 7066 enacted by the Florida legislature after the passage of amendment four. The judge ruled that court costs and fees amounted to a poll tax and were unconstitutional, especially since the state was unable to determine what legitimate restitution or fines were actually owed. There are over 100,000 returning citizens who have no financial obligations at all and can register right now. The focus by League of Women Voters with help from the ACLU of Florida is on contacting these people and helping them to register and enroll in Vote by Mail.

In addition to our successful phone banking campaign, our NCJW section has launched a new project, "Let's Both Vote!" We emailed an explanation of this effort with instructions to all members, asking them to contact the young people in their lives to encourage voter registration and Vote by Mail (VBM) enrollment. Please help to get these young people who are underrepresented in voting to become active voters! NCJW is also partnering with LWV in a postcard writing campaign to encourage VBM for Palm Beach County's young voters.

The US House has passed the HEROES act (Helping Emergency Responders Overcome Emergency Situations) and we need to contact our senators to tell them to do the same. We especially need money for safe and fair elections and need to continue to support families and true small businesses during this pandemic. Encourage your legislators to sign the women's health protection act to make sure women can access the care they need.
