

# Meskwaki Tribal Court Announcement

Meskwaki Tribal Court can now accept payments online for Fines and Fees, including Traffic Violations. You may make payments in full or partial payments. Please note: If making partial payments you must pay in full by the deadline given in your order.

## **To Make a Payment:**

1. Go to [www.citepayusa.com](http://www.citepayusa.com)
2. Select State – Iowa
3. Meskwaki Tribal Court will automatically pop up
4. Select “Make a Payment”
5. The options of “Pay Citation, Fine, or Court Fee” OR “Pay Bail Bond” will appear – user should select which option they want
6. To pay a Fine or Fee, the user must either have their Citation Number and DOB – OR their Case Number and DOB

## **How It Works:**

- ❖ Find Your Information:
  - You will find the amount(s) you owe to the court by entering your citation number or a court case number, and your date of birth.
  - Once you enter in one case number or citation number, you will be able to see any other citation or case fees you have with the court. Please remember some fees will not be on CitePayUSA (jail costs, community service substitutions, etc.) So be sure to check with the Court Staff to ensure you have an accurate balance.
- ❖ Choose What To Pay:
  - All of your outstanding balances will be shown. You then select the item(s) you want to make a payment on. If allowed by the court, you may be able to make a partial payment toward your balance. There is a \$10.00 minimum payment required.
  - If a charge for a case or citation is not eligible for payment – the user will get notice to appear in court
- ❖ Confirm Your Information:
  - You will get the chance to confirm the item(s) selected for payment, and can select your method of payment – either a Credit/Debit card. Meskwaki Tribal Court does not accept Electronic Checks.
- ❖ Make Your Payment:
  - You will be taken to the secured payment page where you can confidently enter your credit/debit card or bank account information.
- ❖ Print Your Receipt:

- You will be given a payment receipt which you can print for your records.
  
- ❖ Case/Citation will disappear
  - Once you have paid the balance in full, the case or citation will no longer be available for viewing on CitePayUSA. Remember, you may still have a balance that CitePayUSA does not account for, please be sure to reach out to the Court Staff to check for any outstanding balances.

#### Information Security:

CitePayUSA cares about your privacy and protects your personal information using the industry's latest technology. Your data is stored behind secure firewalls and all data transmissions are encrypted and protected by security certificates and password authentication. We use monitoring and fail-safe transmission methods to make sure your payment information reaches the court. And finally, your payment details are handled by a secure system that complies with the Payment Card Industry (PCI) standards recommended by the major credit card companies for online transactions.

You can feel confident that your payment will reach the court quickly, securely and in complete privacy
