Dear Affordable Housing Applicant,

Thank you for inquiring about affordable housing in Blairstown. We currently administer several 1-3 bedroom affordable housing units throughout the Township. We advertise for tenants in order to maintain our applicant list. Sometimes apartments may be immediately available, and other times placement is not immediate.

In order to be eligible for an affordable housing unit, you must meet certain income criteria as determined by the New Jersey Council on Affordable Housing. Income limits are determined by region. Blairstown is in **Region 2**, which includes the counties of Essex, Morris, Union and Warren. Income limits can vary from year to year and depend on the number of persons in the household. The last sheet of this application contains the latest income guidelines. (2014 is the current guideline)

If you believe you fall within these guidelines, fill out and submit your completed application. Applications must contain all required documentation to be accepted and reviewed for certification. Applications stay on file for a period of two years, after which the application must be updated. Applicants are contacted as apartments become available. If we contact you that an apartment is available, you meet with the property owner. The property owner makes the final decision on tenancy after reviewing your application and performing credit and background checks.

YOU MUST INCLUDE ALL DOCUMENTATION AS LISTED ON THE ATTACHED CHECKLIST. ONLY COMPLETE APPLICATIONS WILL BE ACCEPTED.

Remember that all applications and documentation are held in strictest confidence.
