REPORT OF BOROUGH OFFICERS

MAYOR - JOHN BROWN, JR.

Mayor Brown read the police and fire reports for November 2016 (see attached).

He attended the Commitment to Community hosted by Western Pennsylvania School for the Deaf and spoke with other elected officials. He was informed that several houses were being demolished in Wilkinsburg.

He attended the Steel Rivers COG Annual Meeting, the ground-breaking ceremony for Forest Hills new borough building, Braddock Hills Annual Light-Up Night, and Allegheny County Boroughs Association dinner.

SOLICITOR – ROBERT GARVIN

Solicitor Garvin stated that Brinton Tower and Brinton Manor applied for tax exemption and was denied. The owner has filed an appeal and they are awaiting the court date.

Mr. Arthrell stated that they have not paid their 2016 borough real estate taxes.

Mr. Ursiny asked what would happen if they do not pay their taxes.

Solicitor Garvin responded that they are delaying their payment because they applied for exemption for 2016 tax year. If they are denied at the next court hearing, then they will be responsible for the taxes and any penalty and interest fees.

ENGINEER - EADS GROUP

Solicitor Garvin read the engineer's report (see attached).

REPORT OF COUNCIL OF GOVERNMENTS: CHAIRPERSON ARTHRELL

Mr. Arthrell stated that they are working on grant applications for the Land Banking project and hopeful that they will have over \$1 million when the project starts.

Mr. Ursiny asked if Braddock Hills has any properties ready.

Mr. Arthrell replied that he has two properties in mind and would like to have five when the project starts.

Mr. Ursiny asked if any of the properties have dwellings on them.

Mr. Arthrell stated that they prefer dwellings because they have a higher value, which means they will bring in more tax money.

THREE RIVERS WET WEATHER: CHAIRPERSON ARTHRELL

Mr. Arthrell attended a meeting with ALCOSAN and is currently fighting with them regarding the locations of a flow meter. He stated that the location would include flow from Swissvale, which would cost the Borough.
