Minutes of meetings held November 17, 1979 and November 19, 1979 were read and approved as read.

Bids for the Diversion Structure were opened and read. L.A. Young Sons Construction is the apparent low bidder with a bid of \$178,885.00. Copy of bid abstract attached to and made a part of these minutes by attachment.

Sam Taylor moved that the District award the contract for the Diversion Structure to L.A. Young, subject to engineer's approval. D.L. Taylor Seconded. MOTION CARRIED.

McDougald stated that John Zimmerman will be ready to proceed with Schumaker Wells No. 1 and 3 in approximately two weeks. Bretzke said that the BLM permit and State Engineer's approval should be received by that time.

Bretzke stated that Grand County has not taken any action toward purchasing state land surrounding the portion of land purchased from J & J Diesel.

McDougald said that he and Bretzke are scheduled to meet with Larry Anderson this morning regarding the designing of the irrigation line.

Discussion was held about a fence around the reservoir, required by BLM. After discussion, Board asked Bretzke to contact Del Backus regarding this matter.

Bretzke stated that the contract for the Sheley Tunnel is being reviewed by Tom Clyde and will be signed by Mr. Gunn in Clyde's office.

Bretzke stated that a budget hearing will be held on December 17, 1979. Board agreed that this hearing should be held at the Ramada Inn Restaurant at 7:00 a.m.
