Bottom summary
Replaced: At each regular meeting of the Executive Committee, the Executive Committee will review and has the option to consider the Applications received since the preceding meeting. The Executive Committee must vote on each Application received, and may approve an Application by a majority vote of the Executive Committee members in attendance at the meeting.
With: The Executive Committee reserves the right to deny applications at any time for any reason.

### 4.5 Annual Membership Dues.

Payment Requirement. The Members of the Corporation must pay Annual Membership Dues, which are due and payable on or before the first Saturday of December of each calendar year at the time of the Annual Membership Renewal Month determined by the Executive Committee. A Member who does not pay his Annual Membership Dues within 30 days after they are due by the last calendar day of the Annual Membership Renewal Month will be subject to automatic termination of his Membership in accordance with Section 4.6.b below.
