My name is Leslie White and/live at 4504 Crews Lane here in Walkertown. I am here representing the Walkertown Girls Softball League as President. Thank you for allowing us to speak to you tonight. Girls have been playing softball here in Walkertown for 47 years. We would like to get information on the use of the Wickenham Park Little League ball fields.
The growth of our league has caused us to have scheduling problems with the limited fields at Walkertown Park off Darrow Road. We have to stop play 30 minutes before the gates close.
Our spring league has grown by $15 \%$ to 130 player's ages 8 to 18 .
We have 90 girls playing in fall ball.
We do not travel to play tournaments.
We are a non-profit.
Doc: Are you no longer in the Dixie USA League?

Leslie: No. I don't know when they stopped. Our talent is not at that level.
Doc: Do you play other teams?
Leslie: No. We don't play travel ball or go to tournaments. We are working to improve skills and build leadership.
We have girls coming from several surrounding counties.
Wesley: Do you have a contract with Forsyth County Parks \& Recreation?
Leslie: Yes. It is renewed year to year. We can't sell hot food there, which limits our ability to raise funds. We are looking for options.
Wesley: What other limitations are there? Or things you have to do.
Leslie: We have to clean up after ourselves which we would do anywhere. We have to haul off large items ourselves. No practice fields makes scheduling harder.
Wesley: How big is your board?
Leslie: 8
Wesley: All Parents?
Leslie: Yes.
Doc: Do you still have a booth at the fair?
Leslie: Yes. We made $\sim \$ 10,900$ this year. We also have a spring yard sale. Wesley: Do you have a yearly audit?
Leslie: No, but we would not be opposed.
Wesley: Would you be offended if we asked for one? Leslie: No.
Doc: Glad you came. Perfect timing. We are working on a Recreation Study now. Leslie: Thank you council for your time!

Marilyn: The Civic Club has always organized the parade. We shouldn't be the organizers at this late date.
Doc: They will have to show liability insurance with no restrictions or exclusions.

Wesley: We met today. Several are retiring, Larry Williams \& Margaret Bessette.
Nothing new from Pat Ivey.
We moved $\$ 100$ million to DOT.
Scott: It's not clear which DOT projects will move forward, dates may change.
They have had administrative problems.
Doc: They are in the pre-appraisers phase now.
Wesley: We discussed the rebranding of the "Carolina Core" to "Piedmont
Triad First", four mega 1800 acre sites, all along the 421 corridor.
Scott: They want 421 to be an interstate.
COG
Scott: We will be doing our Parks \& Recreation study with the COG.

## 4. FINANCIAL STATEMENTS

November, 2019
Doc: We are $41.5 \%$ into the new year. All departments are in line with the exception of some payments made quarterly.
Total expenses are at $27 \%$. Revenue "in" at $27 \%$, which is slow. Property tax has finally moved forward to $24 \%$. Interest coming in well.
Scott: We paid for our paving projects. Expenditures are under budget.
Doc: Unrestricted Funds @ \$3,622,480.62 and Restricted Funds @ $\$ 890,003.41$ for a Grand Total Fund Balance of $\$ 4,512,484.03$.

## 6. MAIN STREET STUDY

Scott: We have received a preliminary aerial view of Main Street from Davenport. The formal report will come later. It would impact our current zoning case
Doc: We have been told by DOT that the traffic counts don't warrant stop lights. Wrong.
Scott: Right. Signals are warranted on Main Street at Pine Hall Road, Depot Street and Harley Drive. Main Street would have a left turn lane onto Harley Drive.
We will be working with the school system to stop staging pickup traffic on Friendly Road and move it onto school property.
Doc: Would council be okay with Scott going to DOT with the intersection traffic counts to get stop lights?
Wesley: When will we get the formal study?
Scott: The first of the year. We could move forward with the stop lights now.
