#### **BYLAW ENFORCEMENT**

Rolling Oaks adheres to bylaws which can be found on the website. These bylaws were established by the developer and are enforced by the Board through a formalized process which can also be found online.

Bylaws prohibit items like boats and RV's from being stored in driveways or in the street, as well as prohibit fences with the exception of properties that border M-59 or Byron Rd.

Finally, the bylaws require trash and recycling recepticles to be kept out of sight. It is asked for recepticles to be brought up from the curb by the next day after trash pick-up. Finally please be respectful of your fellow neighbors and keep trash and recycling receptacles concealed and close to your house/garage or placed in a more courteous location during the week.

# **Important Message**

### **Natural Gas and Wood Burning Fireplaces**

**Rolling Oaks Subdivision** 

#### January 19, 2016:

To all Residents of Rolling Oaks Subdivision,

As you may or may not be aware on Christmas Day 2015 a resident in your community suffered significant loss to their home due to a chimney fire. The cause of the fire was determined to be blown in insulation in direct contact with the fire box in the chimney chase. It is our understanding that this was done after the home was built due to frost build up and cold air drafts around the fireplace.

Most wood burning and natural gas fired fireplaces require a minimum clearance between combustible materials and the exterior of the fire box. This was not the case in this instance and it caught fire.

The Howell Area Fire Department is concerned that this may have been done to other fireplaces in your neighborhood and suggest that an effort by each homeowner is made to ensure that there is no insulation materials in direct contact with their fireplace.

This is a reminder that all fireplaces should be cleaned and inspected at regular intervals by a professional chimney sweep or contractor.
