Risk Reduction Course Information:

The class includes 20 hours of alcohol and drug abuse education as required by Georgia Law. The curriculum is Prime for Life ® from Prevention Research Institute and is the only approved curriculum allowed by Georgia law. The program assists clients to better understand alcoholism and drug addiction as a lifestyle related health problem and how to manage their risk of future problems.

The fees for the course are mandated by law and may not be changed:

- Assessment fee: \$ 100.00
- Course fee: \$255.00
- TOTAL: \$355.00

Payment of all required fees must be made **before** services can be rendered. The assessment must be completed **prior** to beginning the class. Assessment results are provided during class. All information you provide is confidential.

Clinical Evaluations: \$95.00

Anyone convicted of two or more alcohol or drug offenses in ten years may be required by the D.D.S. to complete an alcohol and/or drug abuse evaluation (sometimes called a clinical referral); which can only be done by a state approved clinical evaluator. We will provide you with a list of approved evaluators and can make arrangements for your evaluation at the location of your choice, including all of our offices. These are done by appointment only.
