

3/11/2018

Deputy Blamble arrested Jennifer Daugherty for a child support warrant from Monroe County Juvenile Court. She was transported to the Monroe County Jail.

Deputy Ridley performed a traffic stop and arrested a juvenile for underage consumption of alcohol, OVI and open container. Later released to mother with a citation.

Sgt. Yonley investigated a death at 50846 State Route 145 in Malaga. The male subject was found deceased in his residence and was determined it was natural causes. Case closed.

Deputy Gavin arrested a male that crashed on Atkinson Run Road for OVI and Open Container. He was booked into the Monroe County Jail.

Sgt. Peska responded to an assault on Ensinger Lane. Upon arrival parties were separated. After speaking with both parties involved, they didn't want charges pressed or fill out statements about the incident. Informational report filed at MCSO.

3/12/2018

Deputy Gavin investigated a crash in Clarington at the mini-mart. Driver at fault was issued a citation for DUS and no insurance.

Deputy Barton arrested a male on a misdemeanor warrant out of Guernsey County.

3/13/2018

Deputy Galloway and Deputy Schuerman responded to a burglar alarm on Neuhardt Road. No signs of any criminal activity. Deputies cleared the scene.

3/14/2018

Deputy Weekley investigated a one car accident on County Road 2. The driver of the vehicle was cited for failure to control.

On March 16, 2018 three suspects were taken into custody after a search warrant was executed by the Monroe County Sheriff's Office Special Response Team & detectives.

Stemming from a three month long narcotic investigation, Deputy Russell obtained a search warrant for the residence of Tammy S. Forshey and Joseph C. Blevins of 30001 Township Rd. 232 Lewisville.

Upon executing the search warrant Tammy S. Forshey, Joseph C. Blevins and Peter N. Jones, all of which were residents of the property were taken into custody. During the search investigators located methamphetamine, marijuana, drug paraphernalia, prescription medication, scales and firearms. All three subjects were incarcerated in the Monroe County Jail.

3/17/2018

Deputy Ridley responded to a one vehicle crash on State Route 7 near Sardis. Driver reported falling asleep and wrecking. During the investigation drug abuse instruments was located. Driver was issued a citation.

The Monroe County Sheriff's Office received a call-in reference to a male walking in camo on State Route 26 near Graysville. Also, the Monroe County Sheriff's Office received a call from a female advising that her husband is threatening to do harm to himself. After further investigation, both calls were about the same person. Contact was made with subject and was very distraught and intoxicated. After speaking with the subject for several minutes, he was taken to Marietta Memorial Hospital for a mental evaluation.

The Monroe County Sheriff's Office received a call-in reference to suspicious activity in Antioch. Caller advised it appeared someone has messed with their door to their trailer. (Under Investigation)

Sgt. Peska and Deputy Barton responded to an alleged Domestic violence call. Upon arrival, both parties were separated. Upon further investigation, it was determined that there was no physical violence all verbal. An informational case was completed.

Suspicious vehicle was parked at the Lewisville Carry-Out. Upon arrival at the Carry-Out, the vehicle had left. Sgt. Peska patrolled the area and had negative contact with any vehicle matching the description given.

An accident was called in on State Route 145, near Harper Ridge Road with no injuries. Upon investigating the accident, it was determined that Unit 1 lost control and hit Unit 2. A citation was issued to Unit 1 driver for failure to control. Unit 2 driver was transported to the hospital.

Deputy Barton responded to possible burglary and theft on Graham Road. After investigating the complaint, Deputy Barton was able to obtain a juvenile suspect.
