The purpose of this course is to promote workplace safety and health and to make workers more knowledgeable about workplace hazards and their rights. To provide students with information and skills necessary to work safely in the Construction Industry. This course will give students insight into the various OSHA Standards related to Construction work by examining each Standard closely. A secondary goal of this course is learn the role of the Competent Person for the various Construction Safety Standards. The OSHA 10 Hour Construction Training Program is intended to provide an entry level construction worker's general awareness on recognizing and preventing hazards on a construction site. An overview of the hazards a worker may encounter on a Construction site. Training emphasizes hazard identification, avoidance, control and prevention.
