#### From the President.....

#### Neighbors,

I hope that everyone is doing well after the terrible weather we've had. I know that we had homes suffer water ingress on both the North and South side of Memorial and it's heartbreaking to hear of people needing to do home repairs as a result. What was good to see however was the outpouring of help, neighbors helping neighbors and reminding us why Fleetwood is such a great place to live. One huge takeaway that I got from the storm was how easily the drains can be blocked with loose debris from our yards, or even the odd runaway trash can lid. It certainly pays for us all to keep our yards and alleys clear of debris and our trash cans firmly secured in our garage or behind a fence to prevent being blown into the alley. This will help our drains to run clear when we get such downpours.

This brings me onto a topic which has been the subject of a few questions we've recently received, violation letters. I know that no-one enjoys getting a violation letter, me included when one landed in my mailbox (yes the Board are not exempt). So I just want to take a few lines to explain how the system works. Crest Management do a monthly drive through our neighborhood, note issues that require attention and then send out courtesy letters to the homeowners bringing the subject to their attention and giving a set time to have the issue remedied. If the repair has not been made and the homeowner has not contacted Crest Management to explain why the repair can't be made yet, then a reminder notice will be sent. This process repeats, with a demand letter and ultimately a final demand. The final demand is the last letter issued before legal action is taken.

Typically letters are issued for reasons such as paint peeling on the exterior of the home, mildew on the home, broken fences, overgrown yards, unsightly items stored in full view of the street, alley or neighboring homes and renovation works taking place without prior approval from the Architectural Committee. This isn't an exhaustive list but just some of the more common ones we are seeing at the moment. If you receive a letter and for some reason can't make the repairs in the timeframe requested, please contact Crest Management and explain the situation, this will prevent us simply sending letter after letter.

Please remember that this process is in place to help ensure that Fleetwood is kept looking at its best, keeping it a pleasant place to live and keeping all our property values where they should be.

Hope to see you out and about in the neighborhood this summer.

# Have a Happy and Safe Labor Day! Monday, Sept 5<sup>th</sup> 2016

The first Monday of September means that white clothes are out, sales are in, summer holidays are over and classes begin. For many of us (but not for all of us), it's a welcome day off of work and the day before the start of school.



The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union. The Central Labor Union held its second Labor Day holiday just a year later, on September 5, 1883.

In 1884 the first Monday in September was selected as the holiday, as originally proposed, and the Central Labor Union urged similar organizations in other cities to follow the example of New York and celebrate a "workingmen's holiday" on that date. The idea spread with the growth of labor organizations, and in 1885 Labor Day was celebrated in many industrial centers of the country.

The Olympic Games, which originated in ancient Greece as many as 3,000 years ago, were revived in the late 19th century and have become the world's preeminent sporting competition. From the 8th century B.C. to the 4th century A.D., the Games were held every four years in Olympia, located in the western Peloponnese peninsula, in honor of the god Zeus. The first modern Olympics took place in 1896 in Athens, and featured 280 participants from 13 nations, competing in 43 events. Since 1994, the Summer and Winter Olympic Games have been held separately and have alternated every two years.

The official symbol of the modern games is five interlocking colored rings, representing the continents of North and South America, Asia, Africa, Europe and Australia The Olympic flag featuring this symbol on a white background, flew for the first time at the Antwerp Games in 1920.
