Year to date we have an approximate surplus of \$13,000 and in excess of budget by approximately \$8,000.

AIRPORT ENGINEER'S REPORT

Nik Ippolito discussed on behalf of the airport's engineering consultant, Gale Associates, Inc.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- A pre-bid meeting was held for the rebidding of this project on Wednesday, February 1, 2023. Continental Paving and Sargent Corp were in attendance.
- Bids for this project are scheduled to be opened on February 28, 2023.
- An addendum is being prepared to add to the project two (2) signs located along Taxiway 'A'.
 The Taxiway 'F' and Taxiway 'G' signs will now be replaced as part of the work.
- Grant Applications will be prepared following opening of the bids.

Recommended Actions:

- Please sign and forward grant applications upon receipt.
- Please sign the Notice of Award upon notification of a low bidder from Gale.

REHABILITATE GOLF RAMP AND FOXTROT RAMP

This project is for the design and construction necessary to rehabilitate Golf and Foxtrot Ramps at the Airport.

Project Status:

- The grant is now in place and the first reimbursement request for project related costs has been submitted to the NHDOT/BA.
- The Contractor has started submitting shop drawings for the work.
- At this time, no start date has been provided to Gale. Continental will likely announce a spring start (April-May).

Recommended Actions:

None at this time.

RELOCATE AWOS/SAWS

This project is for the design, bidding, and construction phase services associated with relocating the existing AWOS/SAWS at the Airport. The weather equipment will be moved to a location between Taxiway 'A' on the 14 end, and Taxiway 'B' as depicted on the ALP. It is anticipated that this project will be funded using BIL funds.

Project Status:

- A scoping meeting for this project was conducted on December 19, 2022.
- Gale has not yet received any comments on the draft Scope of Work from NHDOT/BA and FAA.
 We will continue to follow up in order to keep the project moving.
- This project will require two (2) reimbursable agreements with the FAA. One for the design
 associated with their relocated equipment, and one for the construction phase services to install
 the relocated equipment. These agreements must be paid ahead of the grant. The FAA is
 currently in the process of preparing these agreements.

Recommended Actions:

None at this time.

LAND ACQUISITION

This project is for the acquisition of one privately owned parcel.

Project Status:

- During the January Authority meeting, the Authority voted and authorized Gale solicit an Appraiser and Review Appraiser to commence work on the acquisition of one parcel.
- Following the January Authority meeting, Gale solicited proposals for Appraisal and Review Appraisal services.
- A scope and fee have been prepared and presented to the Airport and is included in tonight's package

Recommended Actions:

 Vote to approve Gale's fee of \$23,000.00, inclusive of appraisal and review appraisal services for the acquisition of one parcel and authorize the Chairman to enter into an agreement with Gale Associates. **MOTION BY** Director Duquette to approve Gale's fee of \$23,000.00, inclusive of appraisal and review appraisal services for the land acquisition – L Pine Hill Road, Tax Map E, Lot 50 and authorize the Chairman to enter into an agreement with Gale Associates.
