Dear Applicant:

Thank you for your inquiry about DENTON GREEN LLC apartments.

At the time of application all applicants must be 62 years of age, meet the income restrictions of Denton Green LLC as stated below, and must be able to independently maintain an apartment.

All single applicants must take an efficiency apartment. The rent currently is \$629.00 per month, and with parking \$649.00. All couples must take a one bedroom apartment. The rent is currently \$734.00 per month, and with parking \$754.00. These rentals include utilities.

If an air conditioner is installed, which has to be purchased by the tenant, there is an additional charge of \$200.00 per air conditioner for the season, subject to fair market value, for increased use of electricity for each air conditioner installed.

A one month security deposit will be required on inception of the lease. This security is to be used against damage to the apartment and not to be used as the final month's rent. If there is no damage, and rent payments are current, the full amount of security will be returned to you on termination of the lease.

At present, the building is fully occupied. Qualified Veterans or their surviving spouse, if qualified, will be afforded an admission preference. Proof of Veterans qualification would be the DD214 papers. Proof of a Surviving Spouse includes a copy of the Veterans Death Certificate, copy of the Marriage License, as well as the DD214 papers.

We participate in two programs, The Low Income Housing Tax Credit Program as well as the Mitchell Lama program. Approximately 10% of our apartments follow the Mitchell Lama requirements. There is currently a ten year wait for Mitchell Lama Apartments. The requirements are set forth below:

for One bedroom apt:
\$23,000 minimum / \$61,600 maximum

Mitchell Lama Program:

\$22,300 minimum / \$101,800 maximum
for One bedroom apt:
\$25,500 minimum / \$116,300 maximum
