Board Meeting Highlights

Regular Board Meetings are the Third Thursday at 6:30 PM

July – Supervisor Miller gave his last staff report prior to his retirement. He reported on the maintenance and repairs in the District as well as the progress on the Deer Lick Ln. pipeline project. Chief Ozias reported on the Fire Department calls and the great news that the Department's ISO rating improved to 2/2Y, an excellent rating that some full-time departments are not able to achieve. General Manager Huff reported on promotion of Jason Weber to Field Operations Supervisor, the progress of the new water controller system, and the status of the development of an Emergency Response Plan. The Board unanimously passed and presented to Paul Miler a resolution honoring

his 30 years of service to the District. The lead auditor from SingerLewak presented their annual audit for FY 2019-2020 and the Board voted to accept the audit.

August – Supervisor Weber reported on the maintenance and repairs in the District as well as the progress on the Deer Lick Ln. pipeline project. Chief Ozias reported on the Fire



Department calls, the progress of the station weatherization project, and firefighter promotions. General Manager Huff reported on new employee training and certification preparation, a potential source for a no-cost rate study, and water source status (well levels still in good shape) with regards to the drought situation. The Board approved a revision to the firefighter coverage compensation, performed the annual General Manager review, and voted unanimously to extend General Manager Huff's employment contract for an additional year.

September – Supervisor Weber reported on the maintenance and repairs in the District as well as the continuing progress on the Deer Lick Ln. pipeline project. Chief Ozias reported on calls and responses for the month and gave an update on the picnic and the Caldor fire. In his administrative report, General Manager Huff reported that audit preparations were going well. General Manager Huff presented the budget to actual amounts for FY 20-21 and the Board approved surplus allocations, discussed and approved the 2022 healthcare benefits ceiling limits by motion and resolution, and selected the accounting firm of Halliday & Company to perform the District's FY 20-21 audit.
