ARTICLES OF INCORPORATION

OF'

COUNTRY PARK CONDOMINIUM ASSOCIATION, INC.

ARTICLE I

The name of the corporation is "Country Park Condominium Association, Inc."

ARTICLE II

The corporation shall have perpetual duration.

ARTICLE III

The corporation is organized pursuant to the provisions of the Georgia Nonprofit Corporation Code.

ARTICLE IV

The purpose of the corporation is to exercise the powers of the Association of Country Park Condominium as set forth in the Georgia Condominium Act and in the condominium instruments. The terms defined in Section 44-3-71 of the Official Code of Georgia Annotated shall be deemed to have the meaning therein specified wherever they appear herein unless the context otherwise requires.

ARTICLE V

The corporation shall have the powers set forth in the Georgia Nonprofit Corporation Code.

ARTICLE VI

Each unit owner shall automatically be a member of the corporation during his ownership of his condominium unit.

ARTICLE VII

The members shall have the voting rights set forth in the Georgia Condominium Act Official Code of Georgia Annotated Section 44-3-70 et seq., the condominium instruments and the by-laws.

ARTICLE VIII

The affairs of the corporation shall be managed by a Board of Directors elected by the members having voting rights, as further provided in the Georgia Condominium Act, the condominium instruments and the by-laws, subject to any right of declarant to appoint and remove directors provided for in the condominium instruments pursuant to Section 33 of the Georgia Condominium Act.

ARTICLE IX

The initial registered office of the corporation shall be at Suite 2100, 230 Peachtree Street. Atlanta, Georgia 30303. The initial registered agent of the corporation shall be John G. Morris.

ARTICLE X

The initial Board of Directors shall consist of three (3) individuals, whose names and addresses are:
