In consideration, therefore, for the privilege of riding and/or working around horses at Anamchara Stables, located at Hillsboro, Oregon, or at any other venue in which the undersigned is associated with Anamchara Stables LLC, **the Undersigned does hereby agree to hold harmless and indemnify Anamchara Stables LLC**, their agents, and assignees and further release them from any liability or responsibility for accident, damage, injury or illness to the Undersigned or to any horse owned by the Undersigned or to any family member or spectator accompanying the Undersigned on the premises of Anamchara Stables, or any other venue pursuant to the limitations set forth in Oregon Revised Statutes concerning actions arising out of equine activities ORS 30.687 to 30.697.

"Inherent risks of equine activities" shall mean those dangers or conditions, which are an integral part of equine activities, including but not limited to:

1) The propensity of any equine to behave in ways that my result in injury, harm or death to persons on or around them and/or damage to property in their vicinity;

2) The unpredictability of an equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;

3) Certain hazards such as surface and subsurface objects;

4) Collisions with other equines, animals, people and objects;

5) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or to act within his or her ability.
